1.Title

This direction is cited as the Tasmanian Liquor and Gaming Commission Ministerial Direction (No. 1) 2018.

2.Commencement

This direction takes effect on the day after the day on which notice of it is published in the *Gazette*.

3.Direction

The Tasmanian Liquor and Gaming Commission is, from the date that this Direction takes effect, to so exercise its powers under the *Gaming Control Act 1993* to give effect to those consumer protection measures in the *National Consumer Protection Framework for Online Wagering in Australia - National Policy Statement* that will enhance Tasmania's existing harm minimisation framework and can be implemented and enforced through amendment by the Commission to the Commission's Rules and other technical instruments

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

- (1) Ambulance Service Amendment Regulations 2018
 - These regulations amend the *Ambulance Service Regulations 2016* by prescribing the interstate ambulance services that may be parties to arrangements under the *Ambulance Service Act 1982*.
- (2) Ambulance Service (Fees) Amendment Regulations 2018
 - These regulations amend the *Ambulance Service (Fees) Regulations 2011* by amending certain fees payable under the *Ambulance Service Act 1982*.
- (3) Ambulance Service (Paramedic) Amendment Regulations 2018
 - These regulations amend the *Ambulance Service (Paramedic) Regulations 2014* by specifying that the following persons are paramedics for the purposes of the *Ambulance Service Act 1982*:
 - (a) paramedics employed by certain interstate ambulance services;
 - (b) persons holding registration in the paramedic profession.
- (4) Proclamation under section 2 of the Burial and Cremation Amendment Act 2018
 - This proclamation fixes 26 December 2018 as the day on which the Burial and Cremation Amendment Act 2018 commences.
- (5) Burial and Cremation Amendment Regulations 2018
 - These regulations amend the Burial and Cremation Regulations 2015, consequent on the commencement of the Burial and Cremation Amendment Act 2018, by -

- (a) specifying certain notification and publication requirements in respect of cemeteries; and
- (b) prescribing certain new fees payable; and
- (c) providing for certain persons to enter a cemetery or crematorium for the purpose of ensuring compliance with the *Burial and Cremation Act 2002*; and
- (d) prescribing -
 - (i) new offences and increasing the penalties payable for certain existing offences; and
 - (ii) certain offences as offences for which infringement notices may be issued under the *Burial and Cremation Act 2002*; and
- (e) making minor consequential amendments.
- (6) Local Government (Municipal Boundary Area Adjustment) Order 2018

This order -

- (a) specifies adjustments to the boundaries of the municipal areas of George Town, Glenorchy, Hobart and Launceston; and
- (b) amends the *Local Government Act 1993* to reflect those adjustments.
- (7) Local Government (Model Code of Conduct) Amendment Order 2018

This order amends the Local Government (Model Code of Conduct) Order 2016 so as to reduce duplication of matters contained in the Local Government Act 1993.

(8) Occupational Licensing (Electrical Work) Regulations 2018

These regulations -

- (a) prescribe a range of matters under, and for, the *Occupational Licensing Act 2005* in its application to electrical work including
 - (i) classification of electrical work; and
 - (ii) licensing procedures for electrical contractors, electrical practitioners and nominated managers; and
 - (iii) insurance requirements for electrical contractors; and
 - (iv) requirements, restrictions and recording requirements for electrical work; and
 - (v) infringement notices; and
 - (vi) licensing and other fees; and
- (b) are made consequentially on the repeal of the Occupational Licensing (Electrical Work) Regulations 2008 under section 11 of the Subordinate Legislation Act 1992.
- (9) Poisons (Application of Uniform Standard) Order 2018

This order amends the *Standard for the Uniform Scheduling of Medicines and Poisons*, of the Commonwealth, published by the Australian Government under the *Therapeutic Goods Act 1989*, of the Commonwealth, as it relates to the classification of cannabis as a controlled drug in Tasmania.

(10) Proclamation under section 7 of the Roads and Jetties Act 1935

This proclamation -

- (a) declares portions of Brooker Avenue, the Southern Outlet and the Tasman Highway as State highways; and
- (b) declares portions of certain roads (known as the Davey/Macquarie Couplet) as a single subsidiary road, with the classification of main road; and
- (c) consequentially amends an earlier proclamation (S.R. 1970, No.67); and
- (d) revokes all, or part of, certain spent proclamations in respect of the Brooker Highway, Southern Outlet Highway and Tasman Highway.
- (11) Tasmanian Health Service Amendment Regulations 2018

This statutory rule prescribes the service plan for the Tasmanian Health Service for the 2018-2019 financial year.

(12) Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment Regulations (No. 2) 2018

These regulations amend the Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010 by –

- (a) amending the circumstances in which a vintage vehicle is eligible for an exemption from motor tax; and
- (b) replacing the motor tax rebate for special-interest vehicles with an exemption from motor tax for special-interest vehicles in certain circumstances; and
- (c) updating certain references to remove a trademarked term.
