PUBLIC NOTICE - DATES OF CLOSING OF THE ROCK LOBSTER FISHERY – MARIA ISLAND ZONE

Rule 11(2) of the Fisheries (Rock Lobster) Rules 2011

Pursuant to the powers under the *Fisheries (Rock Lobster) Rules 2011* ("the Rules") that were delegated to the Director (Marine Resources) on 12 November 2018 by the Minister acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* ("the Act"), I hereby determine that the part of the rock lobster fishery that comprises of the activities of the taking of rock lobster, diving for rock lobster, the setting of a rock lobster pot or the use of a rock lobster ring in the "**Maria Island Zone"** is closed from 8 December 2018,

where:

"Maria Island Zone" is defined to mean the area of State waters adjacent to the east coast of Tasmania bounded in the north by the line of latitude at 42° 11' South and bounded in the south by the line of latitude at 42° 49' 00" South, and also including all the waters within Great Oyster Bay north of latitude at 42° 11' South.

Any expression used in this public notice having a particular meaning under the Act or the Rules has the same meaning in this public notice as it has in the Act or the Rules.
