RULE 11 (2) OF THE *FISHERIES (ROCK LOBSTER) RULES 2011*

Pursuant to the powers under the *Fisheries (Rock Lobster) Rules 2011* ("the Rules") that were delegated to the Director (Marine Resources) on 19 August 2015 by the Minister acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* ("the Act"), I hereby determine that the part of the commercial rock lobster fishery that comprises of the taking of giant crab in a rock lobster pot is closed for a period of three years from 1 March 2018 to 28 February 2021 unless the holder of a fishing (licence) rock lobster also holds a fishing (licence) giant crab and giant crab quota units.
