Pursuant to the powers under the *Fisheries (Rock Lobster) Rules 2011* ("the Rules") that were delegated to me on 19 August 2015 by the Minister acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* ("the Act"), in accordance with rule 11 of the Rules, I hereby determine that:

1. the date of the closed season for the **commercial** and **non-commercial** rock lobster fisheries for **female** rock lobster is from 1 May 2018 for all State waters;
2. the dates of the closed seasons for the **non-commercial** rock lobster fishery for **male** rock lobster are as follows:
 - from 1 May 2018 for the "eastern region";
 - from 1 September 2018 for the "western region".
