LIVING MARINE RESOURCES MANAGEMENT ACT 1995

Fisheries (Scalefish) Rules 2015, Rule 11(1)(c)

DATES OF CLOSED PART OF THE SCALEFISH FISHERY

Pursuant to the powers under the Fisheries (Scalefish) Rules 2015 ("the Rules") that were delegated to the Director (Marine Resources) on 27 November 2015 by the Minister acting pursuant to section 20(1) of the Living Marine Resources Management Act 1995 ("the Act"), I hereby determine that the part of the Scalefish Fishery in the area of State waters adjacent to the north coast of Tasmania -

- (a) Bounded in the west by an imaginary line starting at Cape Grim and then running due west along the line of latitude at 40°40'S to the limit of State waters; and
- (b) Bounded in the north by the limit of State waters; and
- (c) Bounded in the east by an imaginary line starting at Cape Naturaliste and then running due east along the line of latitude at 40°50'S to the limit of State waters;

that comprises of the activities of:

- 1. the take of all squid species, including southern calamari (Sepioteuthis australis); and
- 2. the possession of squid other than the possession of Gould's squid by the holder of a Commonwealth authority that were taken under that Commonwealth authority or by the holder of a Tasmanian fishing licence (automatic squid jig) that were taken under the authority of that licence in State waters outside of the closed area:

and is closed from 1 October 2018 to 31 October 2018 (inclusive).

Any expression used in this public notice having a particular meaning under the Act or the Rules has the same meaning in this public notice as it has in the Act or the Rules.

The squid fishery — including calamari and Gould's squid in an area along the north coast will be subject to a spawning closure from 1 October 2018 to 31 October 2018 (inclusive). It is prohibited to take and possess squid in these areas during the closure. Transiting the areas in possession of squid taken outside the area is not permitted (with some minor exceptions). The closure applies to both recreational and commercial fishers. See more details at the DPIPWE website (www.fishing.tas.gov.au). 
