# Anti-Discrimination

ANTI-DISCRIMINATION COMMISSIONER, TASMANIA

## *Exemption/s Granted*

The following application for exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

1. Tasmania University Union Inc – 18/08/024 – Application for an exemption granted under section 57 of the Act for a period of three years.

This exemption has been granted to permit Tasmania University Union Inc to restrict nominations for the student representative positions of Aboriginal and/or Torres Strait Islander Student Representative; Disabilities Student Representative; International Student Representative; Queer Student Representative; and Women’s Student Representative. The restrictions outlined in the exemption order are on the basis that those candidates can share their individual experiences and can speak and advocate from those experiences for students with similar identities.

Granted on the 6th day of September 2018.

The exemption is for the period of three (3) years subject to the fulfilment of the conditions that Tasmania University Union Inc:

- (a) All elected student representatives of Tasmania University Union Inc must undertake a one hour free discrimination information session provided by Equal Opportunity Tasmania by the end of April 2019. This is to increase awareness of rights and obligations under the *Anti-Discrimination Act 1998* (Tas).
- (b) All newly elected student representatives of Tasmania University Union Inc for 2020 and 2021 must undertake further one hour free discrimination information sessions provided by Equal Opportunity Tasmania by the end of April 2020 and April 2021 respectively.

A person may apply to the Anti-Discrimination Tribunal for a review of the Commissioner’s decision **within 28 days from the date of this notice being published.**

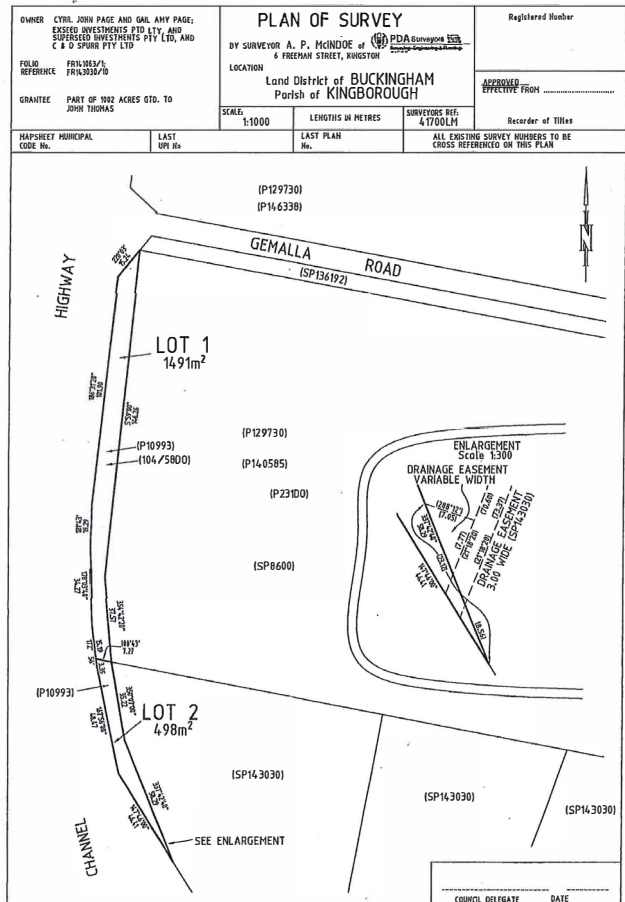
