GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Police Offences Amendment (Prohibited Insignia) Regulations 2019

These regulations amend the *Police Offences Regulations 2014* by prescribing certain motorcycle clubs to be identified organisations for the purposes of the *Police Offences Act 1935*.

(2) Water and Sewerage Industry (Customer Service Standards) Regulations 2019

These regulations -

- (a) prescribe certain matters that must be included in a customer service code, developed by the Regulator in accordance with section 57 of the *Water and Sewerage Industry Act 2008*; and
- (b) are made consequentially on the repeal of the *Water and Sewerage Industry (Customer Service Standards) Regulations* 2009 under section 11 of the Subordinate Legislation Act 1992.
