REVOCATION OF GENERAL AUTHORITY

ANIMAL HEALTH ACT 1995

Section 18

GENERAL AUTHORITY FOR THE IMPORTATION OF CATTLE

I, Kevin de Witte Chief Veterinary Officer, hereby issue a General Authority for the Importation of Cattle.

The following conditions apply:-

- (1) The cattle must be inspected by the owner or person in charge within 7 days prior to movement to Tasmania and found free of signs of disease.
- (2) The cattle must not be known or suspected of being infected with, or exposed to a List A or List B disease, other than Johne's Disease, within 42 days prior to movement to Tasmania commencing.
- (3) The herd of origin must not be subject to any animal movement restrictions.
- (4) Cattle that are infected, or suspected of being infected, with Johne's Disease may be imported provided that all other conditions have been met. The purchaser or recipient of those cattle must be advised that the cattle are infected or suspected of being infected with Johne's Disease.
- (5) The owner or person in charge of the animals in the exporting State or Territory must certify within 7 days prior to movement to Tasmania that, to the best of their knowledge, all the above conditions have been met.
- (6) A Stock Inspector or Government Veterinary Officer in the state of origin must certify that after due enquiry, they have no reason to doubt the 'owner declaration' required by condition 7.
- (7) All certification must be in a form approved by the Chief Veterinary Officer, and must be presented to an inspector when the animals arrive in Tasmania.
