PROHIBITED FEEDING OF DOG OR CAT FOOD TO PIGS

I, Kevin de Witte, Chief Veterinary Officer, acting pursuant to section 53 (1) of the Animal Health Act 1995 hereby issue the following notice:

a person must not:

- (a) feed, or allow another person to feed manufactured dog or cat food to pigs;
- (b) allow a pig to have access to manufactured dog or cat food;
- (c) supply manufactured dog or cat food for a purpose specified in paragraph (a).

In this notice:

'manufactured dog or cat food' means a food has undergone a manufacturing process and that is used or intended to be used as food for dogs or cats.

'pig' means members of the Suidae family.

(1) Registration to Work with Vulnerable People (Risk Assessment for Child-Related Activities) Amendment Order 2019

This order amends the *Registration to Work with Vulnerable People (Risk Assessment for Child-related Activities) Order 2014* to remove the obligation on the Registrar to issue a notice of intent to refuse, suspend or cancel the registration of a person if the person has been charged with, but not convicted of, an offence specified in Schedule 1 to that Order.


