Notifiable Water Contaminants

- I, Dr Mark Veitch, being and as the Director of Public Health, acting pursuant to section 40 of the *Public Health Act 1997* (the Act), declare, effective on and from 4 March 2019, each of the following to be a notifiable contaminant for the purposes of the Act:
- (1) any microorganism or substance for which a health guideline value is set under the Australian Drinking Water Guidelines (published by the National Health and Medical Research Council and the National Resource Management Ministerial Council) as in force from time-to time, if that value is exceeded;
- (2) any microorganism or substance for which a health guideline value is set under guidelines for recreational water (issued under the Act by the Director of Public Health) as in force from time-to-time, if that value is exceeded; and
- (3) any microorganism or substance for which a health guideline value is set under guidelines for regulated systems (issued under the Act by the Director of Public Health) as in force from time-to-time, if that value is exceeded.

The guidelines set out when laboratories must notify the Director of Public Health of contaminants in drinking water, recreational water, and water from regulated systems. 
