### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Criminal Procedure (Attendance of Witnesses) Regulations 2019*

These regulations –

- (a) make provision for the payment of expenses to witnesses in certain circumstances; and
- (b) prescribe forms for certain notices under the *Criminal Procedure (Attendance of Witnesses) Act 1996*; and
- (c) are made consequentially on the repeal of the *Criminal Procedure (Attendance of Witnesses) Regulations 2009* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Dangerous Goods (Road and Rail Transport) Amendment Regulations 2019*

These regulations amend the *Dangerous Goods (Road and Rail Transport) Regulations 2010* to reflect changes made to the National Transport Commission's Model Subordinate Instrument on the Transport of Dangerous Goods by Road or Rail.

(3) Proclamation under section 2 of the *Financial Management Act 2016*

This proclamation fixes 1 July 2019 as the day on which the *Financial Management Act 2016* commences.
