GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the *Justices of the Peace Act 2018*

This proclamation fixes 1 July 2019 as the day on which the *Justices of the Peace Act 2018* commences.

(2) *Justices of the Peace (Code of Conduct) Regulations 2019*

These regulations prescribe a code of conduct for all appointed Justices of the Peace.

(3) Environmental Management and Pollution Control (Smoke) Regulations 2019

These regulations –

- (a) provide that certain wood heaters that are sold in Tasmania, manufactured in Tasmania or imported into Tasmania for sale must comply with AS/NZS 4012:2014 and AS/NZS 4013:2014; and
- (b) regulate the emission of smoke from certain wood heaters, fireplaces, outdoor solid-fuel-burning heaters and outdoor solid-fuel-burning cooking appliances; and
- (c) prescribe certain prohibited wastes that must not be burnt; and
- (d) regulate the burning of vegetation and vegetative waste on certain land; and
- (e) prescribe certain offences to be offences for which an environmental infringement notice may be issued and served.

(4) *Racing (Race Fields) Regulations 2019*

These regulations –

- (a) prescribe the conditions which may be imposed on race field information publication approvals; and
- (b) are made consequentially on the repeal of the *Racing (Race Fields) Regulations 2009* under section 11 of the *Subordinate Legislation Act 1992*.

(5) *Water and Sewerage Industry (General) Regulations 2019*

These regulations –

- (a) prescribe various matters for the purposes of the *Water and Sewerage Industry Act 2008*, including matters relating to water restrictions and requirements for trade waste; and
- (b) prescribe certain offences to be offences for which an infringement notice may be issued and served; and
- (c) are made consequentially on the repeal of the *Water and Sewerage Industry (General) Regulations 2009* under section 11 of the *Subordinate Legislation Act 1992*.

(6) *Water Management Regulations 2019*

These regulations –

- (a) provide for a range of matters relating to the taking of water for the purposes of the *Water Management Act 1999*; and
- (b) prescribe certain fees and entitlements to certain fee rebates for the purposes of that Act; and
- (c) prescribe certain offences for which infringement notices may be issued and the penalties for those infringement notices; and
- (d) are made consequentially on the repeal of the *Water Management Regulations 2009* under section 11 of the *Subordinate Legislation Act 1992*.

(7) *Fisheries (General and Fees) Amendment Regulations 2019*

These regulations amend the *Fisheries (General and Fees) Regulations 2016* by increasing the minimum shell length for abalone –

- (a) taken from the waters within area A; or
- (b) possessed in area A or on land within one kilometre of the waters within area A.

(8) Proclamation under section 20(9) of the *Valuation of Land Act 2001*

This proclamation fixes 1 July 2019 as the date on and after which the fresh valuations of all lands within the valuation districts comprising the municipal areas of Break O' Day, Brighton, Burnie, Central Coast, Circular Head, Clarence, George Town, Meander Valley and Northern Midlands come into force.

(9) *Health (Fees) Amendment Regulations 2019*

These regulations amend the *Health (Fees) Regulations 2017* by increasing certain fees that may be charged in respect of dental services and non-nursing-home-type patients.

(10) *Financial Management Amendment Order 2019*

This order omits Part 1 of Schedule 1 to the *Financial Management Act 2016* and substitutes a new Part 1.

(11) *Inland Fisheries (Seasons and Waters) Amendment Order 2019*

This order amends the *Inland Fisheries (Seasons and Waters) Order 1996* by providing that acclimatised fish may only be taken during a specified period in certain sections of Brumbys Creek, the Macquarie River, the Meander River and the South Esk River.

(12) *Inland Fisheries (World Fly Fishing Championship) Order 2019*

This order specifies that only certain people may take freshwater fish from specified locations during the World Fly Fishing Championship in 2019.

(13) *Defamation Order 2019*

This order, for the purposes of section 35(1) of the *Defamation Act 2005*, declares \$407 500 to be the maximum amount of damages for non-economic loss that may be awarded from 1 July 2019 in defamation proceedings.

LIVING MARINE RESOURCES MANAGEMENT ACT 1995

Section 94

PUBLIC NOTICE -TOTAL ALLOWABLE CATCH FOR THE MACKEREL FISHERY 2019/20

Definition of the parts of the mackerel fishery and the portion of the total allowable catch to be taken in each part

I, Guy Barnett, Minister for Primary Industries and Water administering the *Living Marine Resources Management Act 1995*, acting under Section 94 of that Act, hereby:

1. Set the total allowable catch for the entire commercial mackerel fishery for the open season 1 May 2019 to 30 April 2020 at 5,020 tonnes.
2. Determine that the parts of the commercial mackerel fishery from which the total allowable catch for 2019/20 is to be taken are:
 - a. Blue mackerel (*Scomber australasicus*) to be caught by the holders of a fishing licence (mackerel A);
 - b. Blue mackerel (*Scomber australasicus*) to be caught by the holders of a fishing licence (mackerel B);
 - c. Redbait (*Emmelichthys nitidus*) to be caught by the holders of a fishing licence (mackerel A);
 - d. Redbait (*Emmelichthys nitidus*) to be caught by the holders of a fishing licence (mackerel B);
 - e. Jack mackerels (*Genus Trachurus*) to be caught by the holders of a fishing licence (mackerel A);
 - f. Jack mackerels (*Genus Trachurus*) to be caught by the holders of a fishing licence (mackerel B).
3. Determine that the portion of the total allowable catch to be taken from each part of the commercial mackerel fishery for 2019/20 is:
 - a. Blue mackerel (*Scomber australasicus*) to be caught by the holders of a fishing licence (mackerel A) – 1,496 tonnes;
 - b. Blue mackerel (*Scomber australasicus*) to be caught by the holders of a fishing licence (mackerel B) – 499 tonnes;
 - c. Redbait (*Emmelichthys nitidus*) to be caught by the holders of a fishing licence (mackerel A) – 394 tonnes;
 - d. Redbait (*Emmelichthys nitidus*) to be caught by the holders of a fishing licence (mackerel B) – 131 tonnes;
 - e. Jack mackerels (*Genus Trachurus*) to be caught by the holders of a fishing licence (mackerel A) – 1,875 tonnes;
 - f. Jack mackerels (*Genus Trachurus*) to be caught by the holders of a fishing licence (mackerel B) – 625 tonnes.

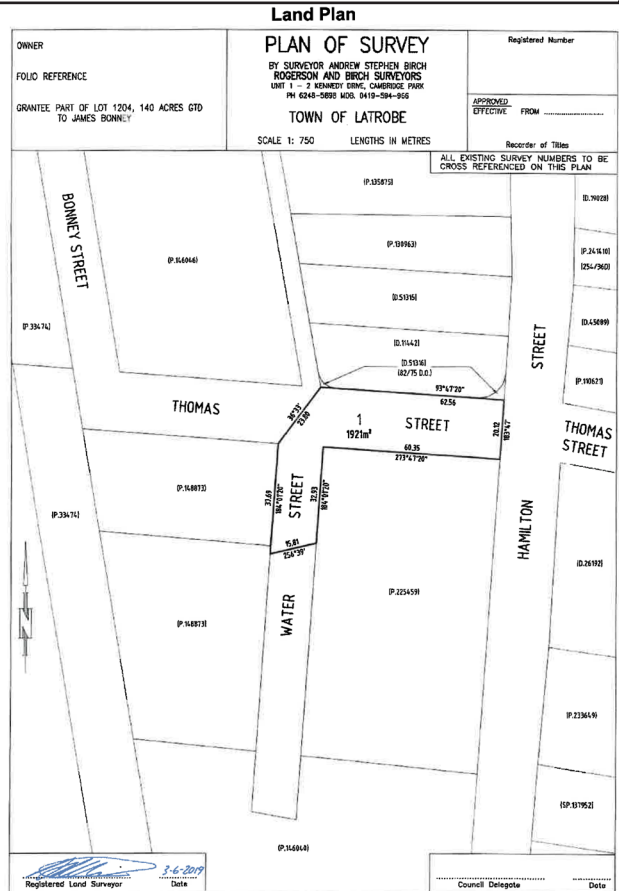
