draft *Plant Quarantine Amendment Regulations 2019*

The Tasmanian Government is committed to providing opportunities for industry and community involvement in the development of Government policy. We are seeking your input on the draft *Plant Quarantine Amendment Regulations 2019*.

A Regulatory Impact Statement (RIS) has been prepared in accordance with Schedule 2 of the *Subordinate Legislation Act 1992*. The RIS provides complete information on the objects of the proposed regulatory changes (which include an increase to fees for specific biosecurity inspection services to further boost frontline biosecurity and other initiatives) and an assessment of the known impacts of the changes.

Submissions are invited on any aspect of this RIS and accompanying draft *Plant Quarantine Amendment Regulations 2019*. Comment is especially invited on the potential costs and benefits of the draft Amendment Regulations for business and other sectors of the community.
