### **Local Government Act 1989**

SUSPENSION OF COUNCILLORS OF THE NILLUMBIK SHIRE COUNCIL AND APPOINTMENT OF AN ADMINISTRATOR

Order in Council

WHEREAS the Minister for Planning and Local Government, Robert Maclellan, has made a recommendation pursuant to section 219(1) of the Local Government Act 1989 that all the Councillors of the Nillumbik Shire Council be suspended (the Minister being satisfied on reasonable grounds that the Nillumbik Shire Council has failed in a serious respect to provide for the good government of its municipal district in relation to its functions and that the failure is ongoing);

AND WHEREAS the Minister for Planning and Local Government being the Minister responsible for the administration of the Local Government Act 1989 has also recommended that the Governor in Council exercise the power conferred by section 219(2) of the Local Government Act 1989 to suspend all of the Councillors of the Nillumbik Shire Council, and to appoint Mr Merv Whelan as an administrator for the Council and to exercise the power conferred by setion 219(4) of the Local Government Act 1989 to specify the date this Order is made.

NOW THEREFORE the Governor in Council acting pursuant to the power conferred by subsections 219(2) and (4) of the Local Government Act 1989 by this Order in Council HEREBY -

- (a) <u>SUSPENDS</u> all the Councillors of the Nillumbik Shire Council;
- (b) <u>APPOINTS</u> Mr Merv Whelan to be the administrator of the Nillumbik Shire Council; and
- (c) <u>SPECIFIES</u> that this Order comes into effect from the date this Order is made.
