- (e) controlling:-
  - (i) sale of goods and services in various locations; and
  - (ii) activities of street vendors and itinerant traders;

- (f) controlling secondary activities on roads including:-
  - (i) trading;
  - (ii) placing of goods and equipment;
  - (iii) repairs to vehicles;
  - (v) processions, street festivals and street parties;
- (g) providing for physical features of the road and adjacent premises to be managed in a way which attends to the safety and convenience of people travelling on or using the road (whether on foot or by vehicle);
- (h) providing for, controlling and managing traffic and the use of roads and premises by persons, animals and vehicles;
- (i) controlling:
  - behaviour on roads, public places and Council land:
  - (ii) the numbering of premises;
  - (iii) the placement of things on roads;
  - (iv) obstructions;
  - (v) the use, construction, repair and removal of vehicle crossings and temporary vehicle crossings;
  - (vi) the removal and impounding of vehicles and other things; and
  - (vii) clothing recycling bins;
- (j) limiting the use of public places by a certain class of vehicle;
- (k) controlling:-
  - (i) fires, incinerators and fire prevention;
  - (ii) amenity, condition and use of premises;
  - (iii) motorised vehicles;
  - (iv) advertising and bill posting
  - (v) camping;
  - (vi) animals;
  - (vii) drainage;
  - (viii) noise; and
- (l) maintaining at all times a clean and sanitary condition in the municipal district;
- (m) environment control, protection and conservation; and
- (n) generally maintaining the peace, order and good government of the municipal district.

The proposed Local Law seeks to achieve its objectives by requiring that certain activities may not be undertaken at all or without a permit, exception or licence, allowing for conditions and fees to apply for permits or licences and conditions to apply for any exemptions.

It allows for notices to comply to be issued in certain circumstances such as where conditions of a permit are not being met and provides for authorised officers to prosecute offences whether by the issue of infringement notice or by court procedures.

The proposed Local Law will apply to the whole municipal district except in those circumstances where its provisions apply to a localised area or allows for designation of further areas by resolution of Council with appropriate notice and signposting.

#### OPEN AIR BURNING -LOCAL LAW NO. 2

The purpose (objective) of the proposed Local Law is to:-

- (a) prevent the outbreak of fire;
- (b) prevent and abate nuisances;
- (c) regulate the lighting of fires in the open air; and
- (d) provide for environmental control, protection and conservation.

The general purport of the proposed Local Law is to regulate open air burning by restricting burning in urban areas and prohibits fires on certain days and prohibits the burning of certain substances. The proposed Local Law provides enforcement powers to authorised officers of Council to direct fires to be extinguished and to issue infringement notices. Permits may also be granted by Council for burning to occur at other times.

#### STREETS AND ROADS -LOCAL LAW NO. 4

The purpose (objective) of the proposed Local Law is to regulate the use of streets and roads in the municipality.

The general purport of the proposed Local Law is to regulate activities relating to the use of streets and roads in the municipality and in particular:-

- (a) management of roads for traffic;
- (b) control of vehicles and animals on roads;
- (c) secondary activities on roads, e.g. advertising signs, roadside trading, door to door trading, outdoor eating facilities, bulk rubbish containers, street parties and festivals, collections and busking;
- (d) management of parking; and
- (e) administration.

#### PUBLIC AMENITY AND SAFETY -LOCAL LAW NO. 6

The purpose (objective) of the proposed Local Law is to provide a safe and healthy environment in which the residents of the municipal district enjoy a quality of life that meets the general expectations of the community.

The general purport of the proposed Local Law is to regulate activities relating to public amenity and safety in the municipality and in particular:

- (a) safety of people and property;
- (b) the environment;
- (c) animals;
- (d) disposal of waste; and
- (e) administration.

The proposed Local Laws if made, would apply to the whole of the municipal district.





REGULATORY IMPACT STATEMENT

Road Safety (Vehicle Registration)
Regulations 1999

Notice is given in accordance with section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement has been prepared in relation to the Road Safety (Vehicle Registration) Regulations 1999.

The current regulations regarding the registration of vehicles, the Road Safety (Vehicles) Regulations 1988 will be revoked on 9 February 1999 in accordance with section 5 of the **Subordinate Legislation Act 1994**. The Road Safety (Vehicle Registration) Regulations 1999 are proposed to provide a replacement set of regulations to give effect to the provisions of the **Road Safety Act 1986**.

The objectives of the proposed regulations are to ensure accountability for the use of vehicles, to ensure that vehicles are safe for use and are operated in a safe manner, and to collect appropriate fees. It is proposed that the objectives of the regulations will be achieved through the establishment of a registration and permit system.

The proposed regulations establish:

- a system of registration for motor vehicles and trailers;
- categories of exempt vehicles and vehicles which may be registered with conditions;
- provisions for application for: renewal, transfer, curtailment and evidence of registration;
- some obligations for registered operators (formerly called owners) of vehicles;
- provision for the issue of notices in respect of defective vehicles and licensing of persons to check vehicle roadworthiness;
- · requirements in hazardous areas; and
- registration and administrative fees;

The benefits of the proposed regulations exceed the costs by \$77 million per year, plus substantial social and environmental benefits. No other realistic alternatives to the proposed regulations, or to individual Parts, were identified. The regulations are capable of enforcement.

The proposed regulations would implement the agreed national policy approved by the Ministerial Council for Road Transport. Each Australian State and Territory has agreed to adopt similar regulations. During development of the national policy, the National Road Transport Commission consulted widely.

The proposed regulations impose a restriction on competition in terms of the *Guidelines for the Application of the Competition Test to New Legislative Proposals* as VicRoads is the only provider of registration services. However, the social and economic benefits warrant this restriction.
