## Gas Industry Act 1994

## **DIRECTION UNDER SECTION 62G**

I, Alan Robert Stockdale, the Minister responsible for the **Gas Industry Act 1994** ("Act"), in exercise of my powers under section 62G of the Act, HEREBY DIRECT that my direction of 26 September 1998 to persons who transmit, distribute and supply liquid petroleum gas (as amended by my further direction of 2 October 1998) be further amended by deleting paragraphs 3 and 4.

This Direction takes effect at and from 9.30 a.m. on 16 October 1998.
