PROPOSED LAND ACQUISITION AND COMPENSATION REGULATIONS 1998

Notice of Intention to Proceed to Make Regulations

I, Jan Wade, Attorney-General, hereby give notice of my intention to proceed with the making of the proposed *Land Acquisition and Compensation Regulations* 1998.

A Regulatory Impact Statement was prepared and advertised inviting public comment and submissions in relation to the proposed Land Acquisition and Compensation Regulations 1998.

The major objectives of the proposed Regulations are to prescribe forms, fees, procedures and other matters for the purposes of the Land Acquisition and Compensation Act 1986. The Land Acquisition and Compensation Act 1986 establishes uniform practices to be adopted in the course of compulsory land acquisitions by acquiring authorities with land acquisition powers.

One submission was received in relation to the proposed Regulations. The submission related to the format of Form 16 of the proposed Regulations. As a result of the submission received and further consultation, minor amendments have been made to Regulation 27 and Part A of Form 16. Regulation 28 has been deleted.
