



BERWICK PLANNING SCHEME Notice of Amendment

#### Amendment L143

Casey City Council has prepared Amendment L143 to the Local Section of the Berwick Planning Scheme.

The Amendment proposes to introduce a site specific clause to the Berwick Residential – Normal Density Zone to allow the use of the

land at No. 747 Princes Highway, Berwick for an office, training and amenity facility in association with the existing motor vehicle sales premises that operates on the adjoining land (No. 749 Princes Highway, Berwick). The Amendment will also exempt any subsequent planning permit application from the requirements to give notice under Section 52 of the **Planning and Environment Act 1987**.

The Amendment will enable the proponent to increase the floor area available for the administration of the current car selling activities. Other commercial uses will be prohibited as the subject site remains in the Berwick Residential - Normal Density Zone.







Ultra Heat Treated Milk (UHT milk) is milk that is processed by subjecting the project to a temperature of not less than 132 degrees centigrade for not less than one second and aseptically packaging it in approved hermetically sealed packages.

Ultra Heat Treated Milk with 5% Ultra Filtered permeate added is UHT milk as defined above with 5% (by volume) of ultra filtered permeate added.

Flavoured milk is milk to which flavouring, as defined in the Food Standards Code, has been added so as to alter the odour or taste of the milk to an appreciable extent.

Concentrated skim milk and concentrated whole milk used in the manufacture of market milk is market milk.

Milk used in the production of "Vita Plus" is market milk for the purposes of the above Act.




