Pipelines Act 1967

Notice under Section 22(3) of the **Pipelines Act 1967**

This notice is published in accordance with the requirements of Section 22(3) of the Pipelines Act 1967.

Transmission Pipelines Australia (Assets) Pty Ltd (hereafter referred to as the "applicant") submitted two applications for Permits to Own and Use a Pipeline ("the permits") under the Pipelines Act 1967 for the construction of underground pipelines which would transport gaseous hydrocarbons from Iona to Colac and Colac to Lara.

Notice is hereby given that if -

- (a) the applications for the permits are granted; and
- (b) notices are published in accordance with Section 22A of the Pipelines Act 1967;

an easement will be compulsorily acquired by me over all land which is "available for compulsory acquisition" under Section 12AB and Part III of the Pipelines Act 1967, and which has not been acquired by agreement through negotiations with Transmission Pipelines Australia (Assets) Pty Ltd. The easements compulsorily acquired will vest in the permits holder.
