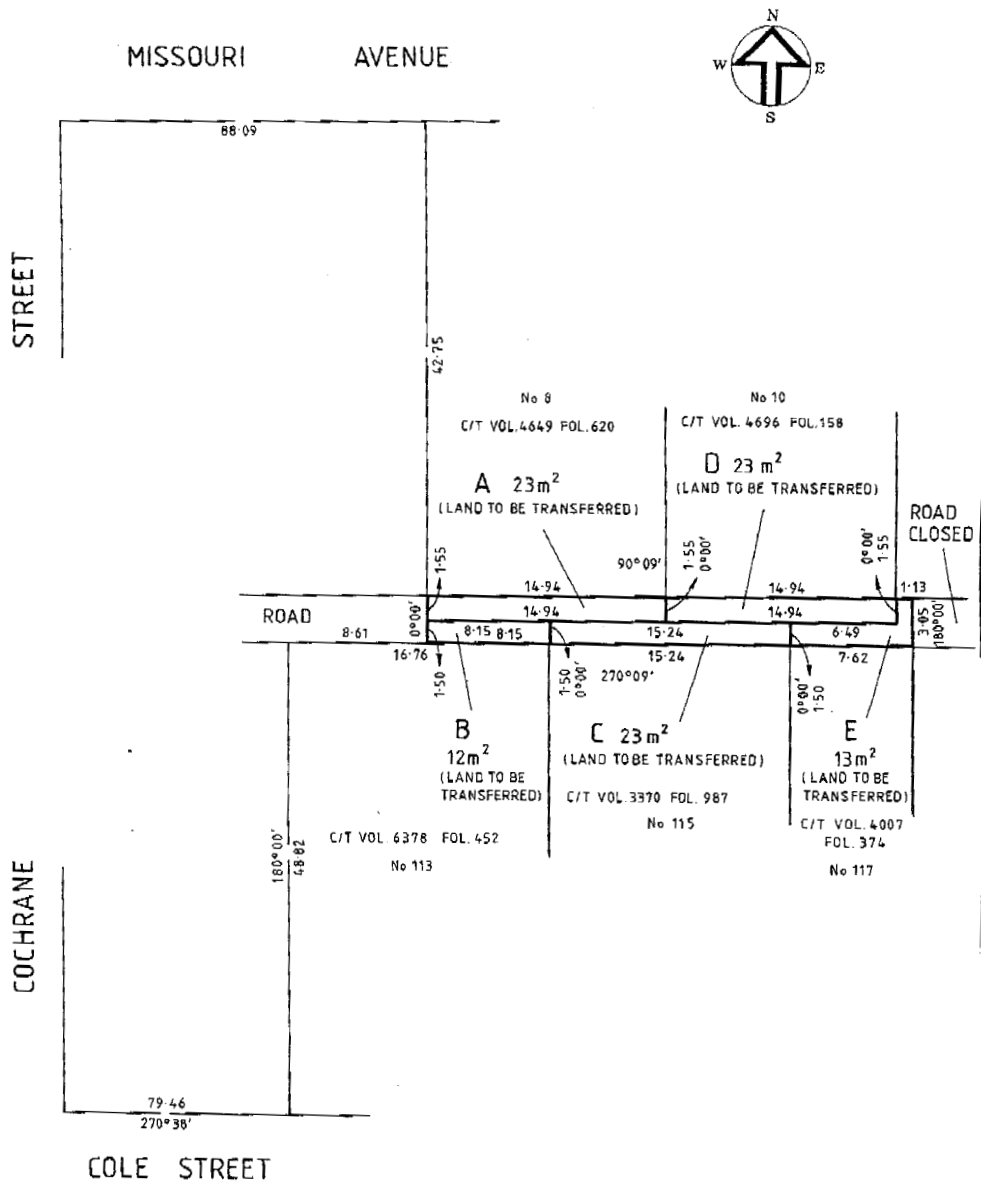

- The day-to-day work involves working on a one-to-one and group basis with women about sensitive women's health issues. The main issues covered are occupational, reproductive and sexual health. The sensitive nature of reproductive and sexual health issues makes it crucial that the consultations are conducted in a women only environment.
- WICH work with NESB women from many different backgrounds, with the aim of matching the client's cultural and linguistic background with the background of the worker. This enables communication about specific women's health issues, which may

vary depending on the cultural context, to be effective, accurate and relevant.

- WICH conducts Industry Visit Programs, where the bilingual workers discuss health issues with women at their workplace during lunch breaks. Rapport with women needs to be established in a short space of time and communication needs to be instant. Excellent communication is crucial in the area of health because it is so personal, and a breakdown in communication can have serious consequences.
- WICH also conducts advocacy on behalf of immigrant women in relation to their health needs. For this service to be effective the advocate must have a good understanding, based on experience of the issues that affect their client base, that is migration, racism and discrimination in employment or the health care system.

The Tribunal grants an exemption from the operation of Sections 13, 100 and 195 of the **Equal Opportunity Act 1995**, to enable the applicant to advertise for and employ women from non-english speaking backgrounds.

- Advantage Credit Union and the Victorian Aboriginal Community, in conjunction with ATSI and CreditCare is sponsoring the establishment of Australia's first national Aboriginal Credit Union. This is a major initiative aimed at providing a culturally sensitive financial institution including financial advice to Aboriginal people.
- The credit union is being established specifically to service Aboriginal and Torres Strait Islander ("ATSI") people and to be accepted within the ATSI community it is important that the union is not viewed as another white financial institution. ATSI people will most readily use the services of the credit union if it is seen as being able to provide culturally sensitive financial advice and services.
- The services would be better provided by ATSI people who have an understanding of the culture and the issues affecting ATSI people. ATSI people have an awareness and clear understanding of the needs of their people and are more likely to relate to ATSI customers of a similar background.

The Tribunal grants an exemption from the operation of Sections 13, 100 and 195 of the **Equal Opportunity Act 1995**, to enable the applicant to advertise for and employ Aboriginal and Torres Strait Islander people.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 7 October 2001.
