## ROAD SAFETY (VEHICLES) REGULATIONS 1988

### General Permit For The Operation of B-Doubles

Regulation 724 of the Road Safety (Vehicles) Regulations 1988 authorises the Roads Corporation, by notice in the Victoria Government Gazette, to allow vehicles and loads which exceed mass or dimension limits prescribed in the Regulations to be used on roads.

Regulation 819 of the Road Safety (Vehicles) Regulations 1988 authorises the Roads Corporation to approve a person to use, or cause or permit to be used, on a road a motor vehicle which is towing more than one other vehicle.

Under the above two Regulations, I, Geoff Kloot, delegate of the Roads Corporation, hereby amend the General Permit For the Operation of B-Doubles in the Victoria Government Gazette No. S111 on 16 September 1997, which allows B-Doubles to be used on approved roads, as follows:

#### PART 4 - APPROVED ROADS

Clause 4.1 is amended to delete the following declared road from the list of roads in the Roads Corporation's Western Region where travel was previously not allowed:

Ballarat-Burrumbeet Road between Princes Street and Midland Highway in the City of Ballarat.

Clause 4.2 is amended to include the following unclassified roads where travel is allowed:

#### Cobram

Ritchie Road (Racecourse Road) between Cobram-Koonoomoo Road and Vodusek Meats.

#### Geelong North

Hill Street.

#### Numurkah

Station Street;

Orchard Street;

McDonald Street between Orchard Street and Riverland Oilseeds.

Naring West Road between the Goulburn Valley Highway and Naring Road

Naring Road between Naring West Road and Graeme Sutton Transport's Depot (800 metres east of Hendys Road).

#### Shepparton

Verney Road between Goulburn Valley Highway and Ford Road.

Lemnos-North Road;

Lemnos-Cosgrove Road.

#### Wodonga

Gadsden Court.

This notice is effective from 18 November 1998 until 31 December 1999.
