No. 87/1998 (1) Section 1 and this section come into operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 April 1999, it comes into operation on that day.

No. 88/1998 (1) This Part and Part 2 come into operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 July 1999, it comes into operation on that day.

No. 89/1998 (1) Parts 1, 2 and 4 come into operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 31 December 1999, it comes into operation on that day.

No. 90/1998 (1) Subject to this section, this Act comes into operation on the day on which this Act receives the Royal Assent.

(2) Sections 29, 30, 31 and 32 come into operation on 1 March 1999.

(3) Section 36 comes into operation on 1 June 1999.

No. 91/1998 (1) This Part and sections 8, 17(1), (2) and (4) and 34 come into operation on the day on which this Act receives the Royal Assent.

(2) Sections 9, 10 and 17(3) are deemed to have come into operation on 10 June 1998.

(3) Sections 22 and 23 are deemed to have come into operation on 25 September 1998.

(4) Section 21 is deemed to have come into operation on 22 October 1998.

(5) Section 13(2) comes into operation on a day to be proclaimed.

(6) The remaining provisions of Part 2, Part 3, sections 26(1), 28(2) and (3), 29, 30 and 33 and Part 5 come into operation on 1 December 1998.

(7) Subject to sub-section (8), the remaining provisions of Part 4 come into operation on a day to be proclaimed.

(8) If a provision referred to in sub-section (7) does not come into operation before 1 December 1999, it comes into operation on that day.

No. 92/1998 (1) This Part and Part 2 come into operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 August 1999, it comes into operation on that day.

No. 93/1998 (1) This Act (except Parts 3 and 4) comes into operation on the day on which it receives the Royal Assent.

(2) Subject to sub-section (3), the provisions of Parts 3 and 4 of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 January 1999, it comes into operation on that day.

No. 94/1998 (1) This Part comes into operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 July 1999, it comes into operation on that day.

No. 95/1998 This Act comes into operation on the day on which it receives the Royal Assent.

No. 96/1998 (1) This Part comes into operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 December 1999, it comes into operation on that day.

No. 97/1998 (1) Part 1 comes into operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 December 1999, it comes into operation on that day.

No. 98/1998 (1) This Part and sections 40 to 43 come into operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 January 2000, it comes into operation on that day.

No. 99/1998 (1) Section 1, this section and sections 12, 13 and 14 come into operation on the day on which this Act receives the Royal Assent.

(2) The remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 March 1999, it comes into operation on that day.

No. 100/1998 (1) This section and section 1 come into operation on the day on which this Act receives the Royal Assent.
