Health Services Act 1988

AN ORDER PURSUANT TO SECTIONS 11(1) AND 46(3) OF THE HEALTH SERVICES ACT 1988 IN RELATION TO EASTERN ACCESS COMMUNITY HEALTH INC AND ITS BOARD OF MANAGEMENT

THE GOVERNOR IN COUNCIL pursuant to all enabling powers and sections 11(1) and 46(3) of the **Health Services Act 1988** ('the Act') and on the recommendation of the Minister for Health, by this Order -

Declares, under section 11(1) of the Act, that section 46(2) of the Act does not have effect in relation to the appointment of the board of management of Eastern Access Community Health Inc in so far as the board may comprise more than 9 members until 30 September 2001, and

Appoints, under section 46(3) of the Act, the following natural persons to the board of management of Eastern Access Community Health Inc for the terms specified below:

Dangerous Goods Act 1985

DANGEROUS GOODS (STORAGE & HANDLING) (AMENDMENT) REGULATIONS 1998

On 1 December 1998, the Governor in Council made the Dangerous Goods (Storage & Handling) (Amendment) Regulations 1998 (the Regulations). The Regulations come into operation on that day.

In accordance with section 16 (3) of the **Subordinate Legislation Act 1994**, notice is hereby given of the purport of the Regulations.

The Regulations revoke the Dangerous Goods (Liquefied Gases Transfer) Regulations 1987 and amend the Dangerous Goods (Storage & Handling) Regulations 1989 (the Principal Regulations) in the following ways:

- The definition of "packaging" has been amended to make it consistent with the Australian Code for the Transport of Dangerous Goods by Road and Rail, Sixth Edition (the Transport Code).
- The definition of "storage in bulk" has been amended consequential upon the amendment to the definition of "packaging".

- The definition of "transport tank" has been amended to ensure it includes both a road tank vehicle and a rail tank vehicle.
- Regulation 503 has been amended to ensure a cylinder used or intended to be used for dangerous goods of Class 2 is also filled in accordance with the requirements of AS2030 or other approved standard.
- Certain Regulations which pertain to the transfer of liquefied gases (the substance of which was contained in the Dangerous Goods (Liquefied Gases Transfer) Regulations 1987 which are now revoked) have been clarified and inserted into the Principal Regulations. The new Regulations place restrictions on transfer equipment for the transfer of liquefied gas; place limits on the filling ratio for the transfer of liquefied gas into a tank and prescribe conditions for the filling by volume of liquefied gas into a bulk container.
- A new regulation consistent with a similar provision in the now revoked Dangerous Goods (Liquefied Gases Transfer) Regulations 1987 has been inserted dealing with the use of liquid level gauges with respect to toxic liquefied gases.
- Schedule 2 has been amended to correct an anomaly created by the transition from the Fifth edition of the Transport Code to the Sixth edition, in relation to dangerous goods in aerosols.
