1. Title

This Order may be cited as the Melbourne Cricket Ground (Operation of Floodlights) Order No. 6/1998.

2. Objectives

The objectives of this Order are to -

- (a) specify the day and times during which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be operated; and
- (b) specify the purposes for which the floodlights may be operated on that day; and

(c) make provision in relation to vehicle entry into the Yarra Park Reserve.

PROCLAMATION OF METROPOLITAN TAXI-CAB ZONE AND SPECIFICATION OF LICENSING PROCEDURES

I, Geoffrey Ronald Craige, Minister for Roads and Ports, by Order pursuant to the provisions of section 143A of the **Transport Act 1983** relating to the granting of taxi-cab licences in taxi zones:

a) Proclaim the area bounded by the coastline, the mouth of the Werribee River, a direct line to Cherry Tree Creek and its intersection with the Princes Highway, a direct line to the intersection of Bulban and Ball Roads, a direct line to the Werribee River and its intersection with Hobbs Road, Hobbs, Boundary and Robinsons Roads, Western Highway, Clarke Road, Monaghans Road, a straight line from the intersection of Monaghans Road and Taylors Road to the intersection of Holden Road and Calder Highway, a straight line to the intersection of Bulla Road and Quartz Street, Bulla, Somerton, Oaklands, Konagadera, Mt Ridley, Summerhill, Epping, Bridge Inn and Doctors Gully Roads, Bannans Lane North, Hurstbridge - Arthurs Creek, Heidelberg -Kinglake, Cherry Tree, Kangaroo Ground -St Andrews, Eltham - Yarra Glen and Kangaroo Ground - Warrandyte Roads, Pigeon Bank Lane, Pigeon Bank Gully Creek, Yarra River in a north-easterly direction, Victoria Road, McIntyre Lane, Yarra Glen, St Huberts, Boundary, Killara and Gruyere Roads, Old Gippsland Road, Sebire Avenue, Warburton Highway, Beenak, Wandin East, Queens, Monbulk, Olinda Stonyford. Creek, Barbers, Doughtys, Falls, The Georgian, Olinda-Monbulk, Main, Emerald- Monbulk, Moxhams, Priors, Kallista-Emerald. William, Grantulla, Belgrave - Gembrook, Wellington and Garden Roads, Princes Highway, McNaughton and Kombi Roads. railway line, Westall, Heatherton and Boundary Roads, Old Dandenong, Centre Dandenong, Lower Dandenong, Springvale, Pillars, Wilson and McMahens Roads a direct south line to Rossiter Road, northern boundary of City of Frankston, Eel Race Road to the coastline (hereinafter referred to as the Metropolitan Taxi-Cab Zone), as a

proclaimed taxi-cab zone for the purpose of taxi-cab licence issue under the provisions of the **Transport Act 1983**;

- b) Specify that the fee to be paid for issue of a taxi-cab licence in the Metropolitan Taxi-Cab Zone is to be a fixed price of \$65,000.
- c) Specify that persons eligible to apply for the granting of metropolitan taxi-cab licences are persons who:-
 - do not hold and have never held an interest (including any indirect interest) in a taxi-cab licence issued in Victoria or in a company which holds or has held such a licence (interest does not include operation of a taxi-cab licence under an approved Assignment Agreement);
 - were first issued with a taxi-cab driver's certificate endorsed to driver commercial passenger vehicles classified as "metropolitan taxi-cabs" on or before 31 January 1994 and have continuously held such a certificate since that date;
 - provide evidence of service excellence in the taxi industry; and
 - provide evidence of their length of full time and/or part time service in the taxi industry.
- d) Specify that applications must contain the following particulars:-
 - the taxi-cab zone in which the taxi-cab will operate;
 - the name, date of birth and address of the applicant;
 - confirmation the application is for operation of a High Occupancy Vehicle;
 - details of the applicant's drivers' certificate including date of issue, classification and expiry date; and
 - a declaration of taxi-cab driving experience.
- e) Specify that applications for taxi-cab licences within the proclaimed zone must be received by the Victorian Taxi Directorate no later than the close of business on 3 February 1999.
- f) Specify the following procedures for determination of applications by the Victorian Taxi Directorate:

- (i) The Victorian Taxi Directorate must publish in the Government Gazette a list of names of all applicants who appear to satisfy the criteria specified in paragraph (c) above and whose application is submitted by the time specified in paragraph (d) above. The Taxi Directorate must also publish a notice that invites persons who wish to dispute the eligibility of an applicant to submit any relevant information within 14 days after the date of the publication of the list;
- Before deciding whether to grant an application, the Victorian Taxi Directorate must consider any written submissions made to it in respect of the eligibility of the applicant;
- (iii) Only one licence will be issued to each successful applicant;
- (iv) Where an application is approved, the licence will be issued on payment of the licence fee, in full, referred to in paragraph (b);
- (v) A maximum of 100 metropolitan taxi-cab licences will be issued;
- (vi) All licences issued will be subject to special conditions to ensure efficient and effective provision of taxi services including:
- requirements that the licensed vehicle must be a High Occupancy Vehicle (HOV) capable of carrying at least two occupied wheelchairs and between six and 11 passengers;
- the licensed vehicle must be a new HOV (less than six months old) when first licensed and must not operate beyond a maximum age of 8.5 years calculated from the date of manufacture shown on the vehicle compliance plate;
- compulsory operation of the licensed vehicle on Friday and Saturday nights and such other days specified within the conditions attached to the licences;
- compulsory operation of the licensed vehicle through a depot approved by the Victorian Taxi Directorate to receive and dispatch bookings for HOV taxi-cabs;
- "off the street" passenger hirings being restricted to places within a 7 kilometre

radius of the Melbourne GPO at certain times of the day; and

- authorisation to charge fares 50% greater than the standard metered taxi fare when the licensed vehicle has been hired for the carriage of six or more people except that only the standard taxi fare must be charged if a person in a wheelchair is carried irrespective of the total number of passengers.
- (vii) In the event that the number of eligible applications exceeds the number of licences to be issued, all applications will be ranked in descending order of verifiable metropolitan taxi driving experience commencing first with applicants with full time driving experience and applications will then be considered in that order having regard to their service record and evidence of service excellence in the taxi industry.
- (viii) In the event that the number of eligible applications is less than the number of licences to be issued, all eligible applications will be ranked in descending order of verifiable metropolitan taxi driving experience commencing first with applicants with full time driving experience and having regard to their service record and evidence of service excellence in the taxi industry. Applicants initially approved for issue of a licence will then be invited to take up a second High Occupancy Vehicle Taxi-cab licence under the same terms and conditions.
- (ix) If after completion of the process described in (viii) the total number of licences to be issued have not all been allocated, the process described in (viii) will be repeated until all licences have been issued or all applicants have declined the invitation to take up additional licences.
- g) All applications for taxi-cab licences within the proclaimed zones lodged prior to 24 December 1998 are deemed to have lapsed.

Vocational Education and Training Act 1990

MELBOURNE INSTITUTE OF TEXTILES (MERGER) ORDER 1998

The Governor in Council makes the following Order:

1. Objective

The objective of this Order is to provide for the merger of the Melbourne Institute of Textiles with Royal Melbourne Institute of Technology.

2. Authority of Order

This Order is made under sections 23 and 24 of the **Vocational Education and Training Act 1990** on the recommendation of the Minister for Tertiary Education and Training made in accordance with those sections.

3. Univertisy to be successor in law of Institute and Council

Subject to this Order, on and from 1 January 1999 -

- (*a*) the Institute is merged with the University, the Council is abolished and the University is the successor in law of the Institute and the Council.
- (b) the assets and rights of the Council vest in the University;
- (c) the liabilities and obligations of the Council become liabilities or obligations of the University;
- (d) any scholarship, prize or bursary of a continuing nature administered by the Council and existing immediately before that date shall be administered by the University, but otherwise in accordance with the terms and conditions to which it was subject immediately before that date;
- (e) all contracts, deeds, bonds, agreements, arrangements, guarantees and other instruments (except contracts, agreements or arrangements relating to the members of staff of the Institute) made or entered into by, or on behalf of, or in relation to the Institute or Council and in force immediately before that date have effect as if made or entered into by, or on behalf of, or in relation to, the University;

- (f) all actions, claims, arbitrations, applications and other proceedings (including proceedings on appeal or review) pending or existing immediately before 1 January 1999 by, against, or in relation to the Institute or Council have effect as if they were actions, claims, arbitrations, applications and proceedings by, against, or in relation to the University and may be continued and completed accordingly.
- (g) any permit, licence or authority of any kind whatsoever issued or granted to the Institute or the Council by or under any Act continues to operate (despite anything in this Order) in favour of the University in the same way and to the same extent as it operated in favour of the Institute or Council; and
- (h) all records and documents of the Council become the property of the University.

4. Gifts, trust etc

If -

- (a) before or after 1 January 1999 -
 - (i) a gift, disposition or trust of property is made or declared or is deemed to have been made or declared, or
 - (ii) a trust fund is created -

(whether by deed, will or otherwise) to, in favour of, for the use of, or for the purposes of the Institute or the Council, and

(b) the gift, disposition, trust or trust fund takes effect, or may take effect, or the trust fund may be applied, on or after 1 January 1999 -

the gift, disposition trust or trust fund does not fail only because of the provisions of this Order but, in relation to any matter occurring on or after that date:

(c) in the case of a gift, disposition or trust of property, takes effect as if made or declared to or in favour of the University for a purpose of the University that corresponds with, or is similar to, those purposes of the Council, and

(d) in the case of a trust fund, may be applied as if created in favour of the University for a purpose of the University that corresponds with, or is similar to, those purposes of the Council.

5. Staff of the Institute

- (1) On 1 January 1999, the members of staff of the Institute cease to be such members and become members of the staff of the University.
- (2) A person who becomes a member of staff of the University under subclause (1)
 - (a) is entitled to a salary no less than the person was receiving or was entitled to receive immediately before the transfer, and on terms and conditions no less favourable than those of the person's appointment in the Institute, and
 - (b) continues to have the benefit of all entitlements accrued in respect of the person's appointment in the Institute before the transfer.

6. Students of the Institute

- (1) On and after 1 January 1999, a person who is an enrolled student of the Institute is an enrolled student of the University.
- (2) A person who holds a degree, diploma, certificate or other award of the Institute is entitled on and from that date to the same benefits and privileges as are enjoyed by a person holding an award of the University, as if the award of the Institute were an award of the University.

7. Organisations related to the Institute

On and after 1 January 1999, a reference to the Institute or the Council (by whatever name) in the constitution or rules of a student representative council or student union, whether incorporate or unincorporate, related to the Institute or the Council, has effect as a reference to the University and, in so far as applicable continues to apply to that part of the University carried on on the campus of the Institute.

8. Saving of validity of actions of the Council of the Melbourne Institute of Textiles

This Order does not affect the validity or continuity of anything which has been validly done in accordance with the revoked Orders before this Order takes effect.

9. Revocation of Orders

The following Orders in Council are revoked:

- (a) Constitution of the Melbourne College of Textiles Council Order 1994 made on 6 December 1994.
- (b) Constitution of the Melbourne Institute of Textiles Council Order 1995 made on 1 August 1995.
- 10. Consequential amendment to Vocational Education and Training Act 1990

In Schedule 1 to the **Vocational Education and Training Act 1990**, omit "Melbourne Institute of Textiles".

11. Meaning of Terms

In this Order unless inconsistent with context or subject matter -

"Act" means the Vocational Education and Training Act 1990,

"**Council**" means the Council of the Melbourne Institute of Textiles established by the revoked Orders,

"Institute" means the Melbourne Institute of Textiles,

"**Revoked Orders**" means the Orders in Council referred to in, and revoked by, clause 9,

"University" means Royal Melbourne Institute of Technology established by the Royal Melbourne Institute of Technology Act 1992.

12. Date of Effect

This Order takes effect on and from 1 January 1999.
