## **Planning and Environment Act 1987 KNOX PLANNING SCHEME**

### **Notice of Approval of Amendment Amendment L172**

The Minister for Planning and Local Government has approved Amendment L172 to the Knox Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment rezones approximately 160 hectares of land generally located east of Henderson Road and south of Ferntree Gully

Road, north and east of Karoo Road, along the Monbulk and Ferny Creek Flood Plains, Rowville/Ferntree Gully from Part Knox Rural A Zone, part Knox Stream Zone, part Knox Residential Development Zone and part Reserved Land - Open Space to the Knox Special Use Zone No. 2. The amendment is required to facilitate the development for an 18 hole golf course, a hotel, a function/conference centre, gymnasium/fitness centre, retirement village, offices, medical centre and associated uses. The development will incorporate several lakes to assist in flood water storage.

A copy of the amendment can be inspected, free of charge, during office hours, at the Department of Infrastructure, Customer Service Centre, Upper Plaza, Nauru House, 80 Collins Street, Melbourne and at the offices of the Knox City Council, 511 Burwood Highway, Wantirna South.
