





In granting this exemption the Tribunal noted:

 The Northern Problem Gambling Service is auspiced by the Banyule Community Health Service Inc. The applicant provides community education and problem gambling counselling in the northern metropolitan region of Melbourne.

- The community education aspect of the Service particularly targets population groups who are under-represented in the applicant's counselling service, but who meet the criteria of significant risk, in as much as that can be assessed from current data. The service has thus assessed the need for a program to specifically target the Koori community.
- The basis of the assessment is the high proportion of low income people adversely affected by gambling and the absence of Koori clients from the counselling service in spite of a significant population base in the region.
- The profile of problem gambling clients, as analysed by Melbourne University, and consistent with client analysis from the Victorian Casino and Gaming Authority, suggests that the Koori community should be represented amongst the applicant's clients at least in proportion to their population and socioeconomic base.
- Anecdotal evidence from information sessions the applicant has provided in the community generally as well as to specific Koori groups, indicates significant gambling activity and resultant problems.
- On the advice of experienced Koori community workers the position of Information and Liaison Officer would be most effectively filled by an indigenous person, who would be more readily accepted and have the necessary links within the community.

Casino Control Act 1991 VICTORIAN CASINO AND GAMING AUTHORITY

Variation to the Rules of Games that may be played at the Melbourne Casino, which was published in the Government Gazette on 24 April 1997.

Under section 60(1) of the **Casino Control Act 1991** the Victorian Casino and Gaming

1. For Rule 29 substitute:

"29. If a person is occupying an EGM and is not actively playing that EGM or is occupying an adjacent area such that it restricts another patron from gaining access to play an EGM, that person is in breach of these rules".

2. After Rule 36 insert:

- "37. "Syndicate Play" occurs when three or more persons have acted in concert to affect the chance of any person or persons winning a linked jackpot arrangement. Any person who engages in Syndicate Play is in breach of these rules.
- 38. Any person who induces an EGM player to vacate an EGM or to engage in Syndicate Play is in breach of these rules. Any person who solicits such an inducement is also in breach of these rules.
- 39. A person who interferes, disturbs or intimidates other gaming machine patrons or staff is in breach of these rules."

Administrative Arrangements Act 1983

The Governor in Council makes the following Order:

ADMINISTRATIVE ARRANGEMENTS ORDER (NO. 157) 1998

- 1. This Order is called Administrative Arrangements Order (No. 157) 1998.
- 2. This Order is made under the powers conferred by Section 3 of the **Administrative Arrangements Act 1983** and under every other available power.
 - 3. This Order takes effect on and from 17 February 1998.
- 4. A reference to the Old Body in any provision of an Act specified in Column 2 of the Schedule or in any statutory or other instrument made under an Act specified in Column 2 of the Schedule shall be construed as a reference to the New Body.
 - 5. Where —
 - (a) before this Order takes effect, a transaction happened in relation to the Old Body, then —
 - (b) this Order does not affect the validity or continuity of the transaction, and the transaction shall continue and may be completed in relation to the New Bosy in the same way as it would have continued and may have been completed in relation to the Old Body if this Order had not been made.
 - 6. In this Order —

"The Act" means the Administrative Arrangements Act 1983.

"Body" means Minister.

"Instrument" includes contract and agreement.

"Old Body" and "New Body" means respectively the Bodies specified in Column 1 and Column 3 of the Schedule.

"Schedule" means Schedule to this Order.

"Transaction" includes —

- (a) Agreement, bond, contract, deed or other consensual arrangement whatsoever;
- (b) Action, appeal, arbitration, prosecution and other legal proceeding whatsoever;
- (c) Assignment, charge, lease, mortgage, transfer or other dealing with property whatsoever;
- (d) Loan, guarantee, indemnity or other dealing with money whatsoever;
- (e) Approval, consent, delegation, licence, Order, permit, requirement or other authority whatsoever;
- (f) Notice; and
- (g) Any other act, entitlement or liability in the law whatsoever.

Subordinate Legislation Act 1994 PROPOSED CONSUMER AFFAIRS (PRODUCT SAFETY) (LIGHTERS) REGULATIONS 1997

Under Section 59 of the Consumer Affairs Act 1972, the Office of Fair Trading and Business Affairs is authorised to make regulations to protect the public against risk of death or personal injury associated with consumer products.

The objectives of the proposed Consumer Affairs (Product Safety) (Lighters) Regulations 1997 ("the proposed Regulations") are:-

- (1) to reduce the number of serious injuries and deaths caused by children under five years of age playing with lighters; and
- (2) to ensure that all lighters sold in Victoria function safely.

These objectives are to be achieved by adopting the Trade Practices (Consumer Product Safety Standard) (Disposable Cigarette Lighters) Regulations 1997 (Cth) ("the Commonwealth Regulations"), which commenced operation on 1 March 1997, so that they apply equally to all participants involved in the manufacture, import and supply of lighters in Victoria. The need for this approach is caused by the constitutional incapacity of the Commonwealth to legislate with respect to unincorporated entities operating solely within Victoria (or any other State). As a result of this incapacity, the Commonwealth Regulations do not apply to small, unincorporated businesses such as sole proprietors or partnerships operating exclusively within Victoria.

A Regulatory Impact Statement (RIS) has been prepared for the proposed Regulations. It considers a draft of the proposed Regulations and alternatives to them. It concludes that the objectives of this proposal are best met by the current form of the proposed Regulations.
