Planning and Environment Act 1987 ALPINE RESORTS PLANNING SCHEME Notice of Approval of Amendment Amendment C1

The Minister for Planning and Local Government has approved Amendment C1 to the Alpine Resorts Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment is to allow the use and development of the existing heliport in the Falls Creek Alpine Resort near the Halleys Comet Lift Top Station and Cloud Nine Restaurant until the end of the 1998 declared snow season.
