ELECTION OF DIRECTORS OF THE VICTORIAN SUPERANNUATION BOARD

In accordance with the **Public Sector Superannuation (Administration) Act 1993** and the Victorian Superannuation Board Election Procedures, notice is hereby given that an election of members of the State Superannuation Fund and the Victorian Superannuation Fund to be appointed as Directors and Deputy Directors of the Victorian Superannuation Board for the period from 1 July 1998 to 30 June 2001 will be held on Monday 1 June 1998.
