VARIATION OF PROHIBITED PERIODS

The Prohibited Period shall terminate at 0100 hours on Monday 27 April 1998 in the following municipality:

SCHEDULE 2

The Prohibited Period shall terminate at 0100 hours on Friday 24 April 1998 in the following municipalities:

Delatite Shire Council, Strathbogie Shire Council, Rural City of Wangaratta — south of the Hume Freeway.
