- The Women's Safety Survey, December 1996 (Australian Bureau of Statistics) claims 99% of sexual violence was perpetrated by men.
- Of women who have experienced sexual violence since turning 15 years of age, 100% of the perpetrators were male
- 13% of service users are male (adults and children), in almost all instances they have been sexually abused by male perpetrators. Since most men or boys are abused by other males they usually request a female counsellor. In circumstances where a male requests a male counsellor the applicant will provide them with a list of alternative options in their area. These include male counsellors, social workers, psychologists or psychiatrists who work at North East Child and Adolescent Mental Health Service, Ovens and King Community Health Centre, the Delatite Community Health Service, Wodonga Adult Mental Health Service, the Upper Hume Community Health Service, Yarrawonga Community Health Service, Resolve (Adolescent Mediation Service), the Behaviour Intervention and Support Team (Intellectual Disabilities Services), Upper Murray Family Care and the Department of Human Services.

The applicant will offer to make the referral and organise an appointment for the service user or alternatively provide a list of names and

names and phone numbers if the service user would prefer to make the arrangement himself.

- The centre provides the following services:
  - (a) Counselling for victims/survivors of sexual assault, their families and friends.
  - (b) Group work and facilitating all women therapy groups.
  - (c) Crisis telephone counselling and support during medical forensic examinations.
  - (d) Information and referral regarding medical and legal options.
  - (e) Community education.
  - (f) Professional training.
  - (g) Advocacy for victim/survivors of sexual assault.
  - (h) Court support during a trial.

- "licensee" means the holder of a water or sewerage licence issued under Division 1 of Part 2 of the Act.
- "not-for-profit organisation" means any body or group, corporate or unincorporate, that applies its profits in promoting its objectives and prohibits the payment of any dividends to members.
- "service charge" means the total amount of -
- (a) the service charges imposed under section 22 of the Act; or
- (b) the charges imposed under an agreement in writing, but not including any charges fixed according to the extent of the use of the service provided,

for the provision of sewerage services and water supply services to a property in a financial year.

#### 5. Eligibility for Rebate

- A licensee must excuse payment of up to a maximum of \$260.00 of the service charge imposed in a financial year in respect of a property which, in the opinion of the Commissioner of State Revenue, is -
  - (a) predominantly used by a charitable organisation or charitable organisations for charitable purposes; or
  - (b) predominantly used by a not-forprofit organisation or not-for-profit organisations that exist for the purpose of providing or promoting cultural or sporting recreational or similar facilities or objectives (excluding a body that promotes or controls horse racing, pony racing or harness racing), for outdoor sporting, recreational, cultural or similar outdoor purposes or activities; or

- (c) predominantly used -
  - (i) as a club for or a memorial to persons who served in the First or Second World War or in any other war, hostilities or special assignment referred to in the **Patriotic Funds Act** 1958; or
  - (ii) as a sub-branch of the Returned Services League of Australia; or
  - (iii) by the Air Force Association (Victoria Division); or
  - (iv) by the Australian Legion of Ex-Servicemen and Women (Victorian Branch); or
- (d) vested in or owned by a public statutory body and predominantly used as a public open space or a park.
- (2) The amount to be excused under subclause (1) is to be reduced proportionately according to the proportion of the financial year for which -
  - (a) the person was not liable for the service charge; or
  - (b) the property was not used by an organisation for the purposes described in sub-clause (1).

# 6. Applications

- (1) For the purpose of this Order, an application must be -
  - (a) in the form approved by the licensee; and
  - (b) submitted to the licensee before the end of the financial year to which the service charge relates. commenced


