General Local Law (Miscellaneous Amendments) Local Law 1998.

The purpose of the local law is to make several amendments to the Council's General Local Law 1995 (No. 1).

The local law has amended the principal local law as follows:

Building works which may cause interference with Counci land

A permit is required for building works which may cause interference with Council land. Permit applicants may be required to lodge a bond and to meet inspection costs. If damage is caused the owner and occupier of the land on which building works have taken place may be required to pay for rectification.

Parking offences

Parking offences relating to no-parking areas and parking bays have been created.

Promotional activity on streets

An existing offence relating to the conduct of a street festival or procession on a road without a permit has been extended to apply to promotional activity.

Noise

Amendments have been made to offences relating to noise, including introduction of restrictions on night-time transport of goods from commercial premises and on amplified speech or music which is audible from outside premises.

Advertisements

Amendments have been made to the offence relating to advertisements on Council land.

Drainage of properties

Provision has been inserted for Council to serve a notice to comply in relation to inadequate drainage on properties.

Incinerators and fires

Modifications have been made to the controls on barbecues including insertion of a restriction on emission of ashes and smoke to the extent that it is dangerous or offensive.

Property owners' obligations — fire hazards & unsightly premises

Obligations in relation to unsightly premises

have been extended to owners, occupiers and persons in charge of the premises.

Building operations

The scope of Division 4 of Part 7 ("Building Operations") has been limited to activities which cause noise. Amendments have been made to the days on which building operations must not occur without a permit, and the restriction has been extended to building operations on roads and Council land.

Protection of trees

A new division has been inserted into the principal local law to create an offence if a significant tree on or over private property is cut, trimmed or removed without a permit. A "significant tree" is defined as a tree with a trunk diameter greater than 45 centimetres measured 1.5 metres above ground level or which has been listed by the Council in its significant trees register.

The criteria for issuing a permit include whether the tree has been listed in the register, and health, safety and amenity considerations.

Keeping of animals

An amendment has been made to the definition of "domestic bird" (substituting "quail" for "peacock") and an error has been corrected in relation to the ceiling number of animals which can be kept without a permit.

Other amendments

The local law has revoked provisions of the General Local Law considered to be unnecessary, dealing with removal of shopping trolleys, installation of satellite dishes and measures to control vermin. In addition, amendments have been made to requirements about the duration of time rubbish receptacles may be left on the road for the purposes of collection, an amendment has been made to the objectives clause of the principal local law and new definitions of "council reserve", "parking bay" and "significant tree" inserted.



- 3. For at least 12 months after the suspension is removed pursuant to paragraph 2 of this determination, the nurse's registration shall be subject to the following conditions, limitations or restrictions.
 - (a) The nurse must attend a medical practitioner acceptable to the Board on at least 8 occasions annually on random dates nominated at short notice by the practitioner, and on each occasion undergo drug screenings which the on practitioner must provide satisfactory reports to the Board.

- (b) The nurse must continue counselling with the person(s) who provided the report(s) pursuant to sub-paragraph 2(f) of this determination, at least once a month, or more often if so recommended.
- (c) The nurse must not work as a nurse on night shift.

ORDER PROHIBITING OR RESTRICTING THE ENTRY OR IMPORTATION OF SPECIFIED PLANTS AND PLANT PRODUCTS FROM SOUTH AUSTRALIA TO PREVENT THE SPREAD OF FIRE BLIGHT INTO VICTORIA.

I, Patrick McNamara, Minister for Agriculture and Resources, make the following Order:

1. Objective

The objective of this Order is to prohibit subject to conditions or restrict the entry or importation of specified plants or plant products from specified parts of South Australia so as to prevent the spread of the exotic disease fire blight into Victoria.

2. Authorising provision

This Order is made under section 24 of the **Plant Health and Plant Products Act** 1995.

3. Definition

In this Order -

"Fire blight" means the exotic disease fire blight caused by the bacterium *Erwinia amylovora*.

4. Controls applying to specified plants and plant products

- (1) The entry or importation into Victoria of any nursery plant listed in the Schedule which has been grown in or consigned from that part of South Australia which is within 10 kilometres of the boundary of the Adelaide Botanic Gardens is prohibited.
- (2) The entry or importation into Victoria of any nursery plant listed in the Schedule which has been grown in or consigned

from that part of South Australia which is between 10 and 20 kilometres of the boundary of the Adelaide Botanic Gardens, is prohibited unless -

- (a) the plant has been certified by an officer of the Department of Primary Industries South Australia as being grown in a nursery that-
 - (i) is more than 10 kilometres from the Adelaide Botanic Gardens; and
 - (ii) has been inspected by an officer of the Department of Primary Industries South Australia in the previous Spring and Autumn for visual symptoms of fire blight and evidence of fire blight has not been found; and
- (b) the plant is accompanied by a declaration from the owner of the nursery that the plant has been grown in that nursery for the previous 12 months.
- (3) The entry or importation into Victoria of any fruit of a plant listed in the Schedule that has been grown in that part of South Australia which is within 5 kilometres of the Adelaide Botanic Gardens is prohibited.

TRAINING AND FURTHER EDUCATION RECOGNITION COUNCIL ORDER 1997

The Minister for Tertiary Education and Training makes the following order:

Name of Order

1. This Order is called the *Training and Further Education Recognition Council Order 1997.*

Purpose of Order

2. The Purpose of this Order is to establish a training recognition board and a further education recognition board, to be known jointly as the Training and Further Education Recognition Council (the Council).

Authority for Order

 This Order is made under section 75 of the Vocational Education and Training Act 1990, section 13B of the Adult, Community and Further Education Act 1991 (the Acts) and all other enabling powers.

Date of Effect

4. This Order takes effect on 1 January 1998. Establishment of Training and Further Education Recognition Council

- 5. (1) Pursuant to section 75 of the Vocational Education and Training Act 1990, a training recognition board is established.
 - (2) Pursuant to the 13B of the Adult, Community and Further Education Act 1991, a further education recognition board is established.
 - (3) The training recognition board and the further education recognition board will meet together as the Council.

Duties

- 6. The Council must -
 - (a) comply with all duties imposed by the Acts and instrument of delegation to the Council and any other duties imposed by law; and
 - (b) operate in accordance with economic and social objectives established from time to time by the Government of Victoria; and
 - (c) operate in accordance with applicable national guidelines; and
 - (d) comply with all obligations and duties imposed on the Council by or under this Order; and
 - (e) so far as practicable, exercise and perform all rights, powers and duties conferred or imposed on the Council in a manner consistent with its functions as stated in the Acts; and
 - (f) meet not less than four times in each calendar year and at least once every four months.

Membership

- 7. (1) The Council consists of 11 members appointed by the Minister, one of whom will be appointed Chairperson and another Deputy Chairperson.
 - (2) A member will hold office for the period of not more than three years which is specified in the instrument of appointment.
 - (3) A member may resign by writing addressed to the Minister.

Victoria Government Gazette

- (4) A member ceases to hold office if and when that member is absent from three consecutive meetings of the Council without leave from the Minister.
- (5) The Minister may remove a member from office at any time.
- (6) A member must in the exercise of his or her functions -
 - (a) act honestly; and
 - (b) exercise reasonable care and diligence; and
 - (c) not make improper use of any information acquired as a member; and
 - (d) disclose, in accordance with clause 8 of this Order, conflicts of interest or duties.

Disclosure of Interests of Members

- 8. (1) Members who are directly or indirectly interested in any business of the Council or who hold any office or possesses any property which might cause a conflict of duties or interest must declare that interest or potential conflict.
 - (2) All declaration must be recorded in the minutes of the Council.
 - (3) The requirements of this clause do not apply to conflicts or potential conflicts in respect of positions or offices of employment held which are a necessary qualification for the appointment of a person to the Council.

Procedure

- 9. (1) The Chairperson will chair the meetings of the Council but if the Chairperson is absent the Deputy Chairperson will chair the meetings. If both the Chairperson and Deputy Chairperson are absent, the members present will choose a member to chair the meeting.
 - (2) The Council's quorum is a majority of its members from time to time.
 - (3) The Council may act despite vacancies in its membership so long as a quorum is present.
 - (4) Each member has one vote and questions will be decided by a majority of votes but if votes are equal the

member chairing the meeting will have a second or casting vote.

- (5) The Council must have accurate minutes kept of its meetings and must arrange for copies of all minutes to be delivered to the Minister on request.
- (6) The Council may form and dissolve committees whose function will be to advise or assist the Council in relation to the performance or exercise of any of its powers, duties or functions as determined by the Council from time to time.
- (7) The Council may decide the composition of committees and appointment of committee members provided that -
 - (a) the Council must appoint at least one of its members to every committee; and
 - (b) the Council must appoint the Chairperson of each committee who in each case must be a member of the Council; and
 - (c) the Council must have the power of appointment and removal of members and the Chairperson of every committee; and
 - (d) in deciding the composition of each committee, the Council will attempt to maintain an appropriate balance of relevant backgrounds and experience; and
 - (e) members of committees will hold office for the period (not more than one year) specified in the instrument of appointment; and
 - (f) a committee member can resign by writing addressed to the Chairperson of the Council; and
 - (g) a committee may give a committee member leave from attendance at its meetings.
- (8) Subject to the Acts and this Order, the Council may regulate its own procedure.

- 1. The criminal liability of persons for actions performed while in a state of self-induced intoxication.
- 2. Whether it is desirable that the decision of the High Court of Australia in *The Queen v. O'Connor* (1980) 146 CLR 64 continues to state the law in Victoria.
- 3. Whether it is desirable to introduce an offence of committing a dangerous act while grossly intoxicated.

In conducting the Inquiry the Committee is to have regard to:

- a. The report of the Law Reform Commission of Victoria on *Criminal Responsibility: Intention and Gross Intoxication* (November 1986).
- b. The report of the Criminal Law Officers Committee of the Standing Committee of Attorneys-General on the *Model Criminal Code: Chapter 2 - General Principles of Criminal Responsibility* (December 1992).
- c. The report of the New South Wales Law Reform Commission on Partial Defences to Murder: Diminished Responsibility (May 1997).
- d. The report of the English Law Commission on *Legislating the Criminal Code: Intoxication and Criminal Liability* (February 1995).
- e. Recent Australian legislation abrogating the decision in *O'Connor*.
- f. Such other legislation, case law, reports and materials as are relevant to the Inquiry.

The Committee is requested to make its final report to the Parliament by the first day of the Autumn 1999 Parliamentary sittings.


