Notice of Approval of Amendment  
Amendment L57

The Minister for Planning and Local Government has approved Amendment L57 to the Stonnington Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment allows land in the Melbourne City Link project area as it applies to the Kooyong Tennis Club to be removed from the scheme and to extend the City Link Project Map area to include land within St Kevin's College.

The Amendment changes the regional section of all metropolitan regional planning schemes to make seven of the Melbourne City Link advertising signs subject to planning permits at locations in North Melbourne, Port Melbourne, Melbourne, Southbank and Burnley. The Amendment also amends the local sections of the Melbourne and Yarra Planning Schemes to make the Minister for Planning and Local Government the responsible authority.
