Notice of Approval of Amendment

Amendment L249

The Minister for Planning and Local Government has approved Amendment L249 to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment includes an Incorporated Document in Clause 315-5 of the Melbourne Planning Scheme which allows the land at 204-218 Lygon Street, Carlton, to be developed and used for the purpose of an entertainment centre and ancillary uses with associated carparking, in accordance with specific plans and conditions.
