Amendment RL184

The Minister for Planning and Local Government has approved Amendment RL184 to the Boroondara, Hume and Whittlesea Planning Schemes.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment corrects some minor errors in Amendment RL182. This includes reinstating buildings that were removed from the Boroondara ordinance, removing the Bridge at Kalkallo from the schedule to the heritage overlay of the Whittlesea Planning Scheme and correctly listing it in the schedule to the heritage overlay of the Hume Planning Scheme. The Amendment also changes the second Clause 134B titled Heritage Overlay Scheme to Clause 134C.

Planning and Environment Act 1987 STONNINGTON PLANNING SCHEME Notice of Approval of Amendment Amendment L58

The Minister for Planning and Local Government has approved Amendment L58 to the Stonnington Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment inserts a site specific clause that requires a planning permit to be obtained prior to the demolition of certain buildings that are included in a schedule as an incorporated document. The clause will remain in force until 30 November 1998.
