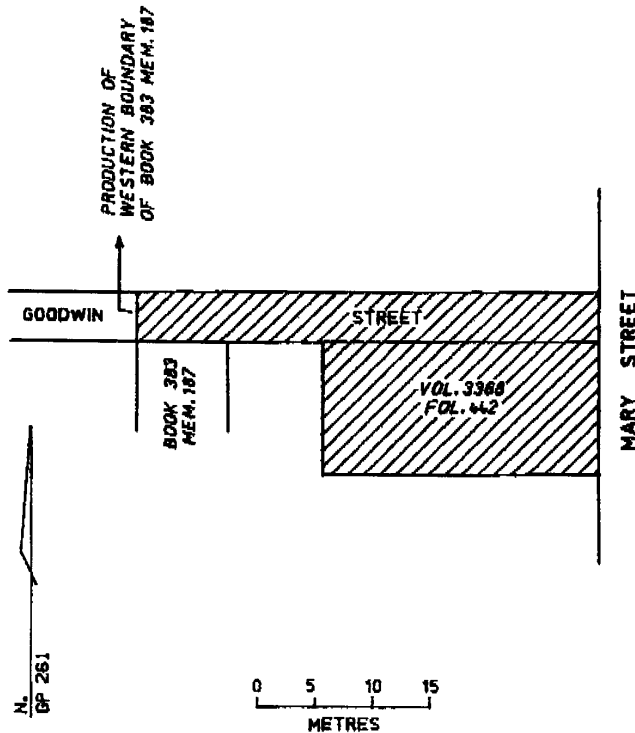

UNDERGROUND LAND AT RICHMOND

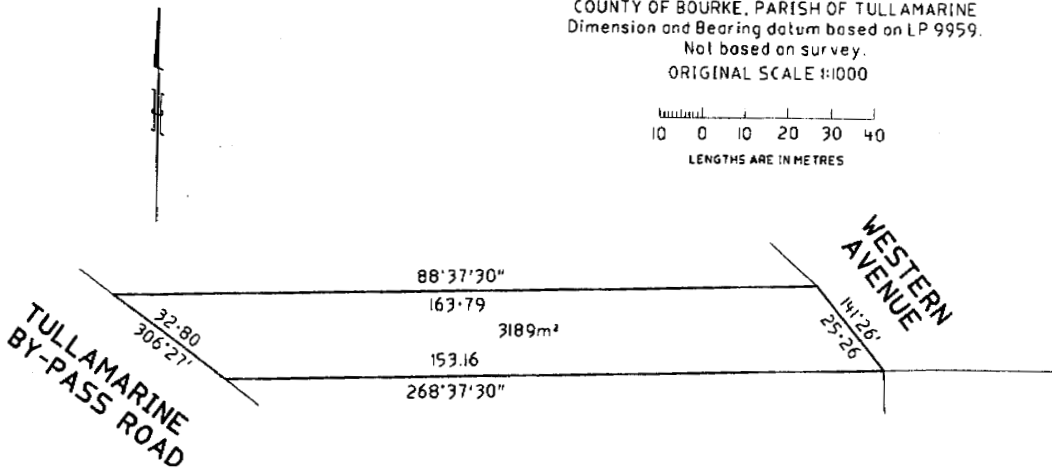
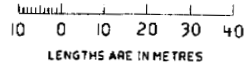
