DECLARATION OF A COMMUNITY HEALTH CENTRE

I, Des O'Shea, Regional Director, Northern Metropolitan Region, and delegate of Warren McCann, Secretary to the Department of Human Services, Victoria, being satisfied as to matters referred to in paragraphs (a) and (b) of Section 45 (1) of the **Health Services Act 1988**, declare under that section:-

- (i) the agency listed in column 1 of Schedule 1 to be a community health centre, and
- (ii) the area specified in column 2 of Schedule 1 opposite the name of the agency to be the area served by that centre.
