### NOTICE OF DECISION (S 12)

Proposed By-Law No. 2:

#### Waterways and Drainage Protection

I, Patrick McNamara, Minister for Agriculture and Resources, and Minister responsible for the **Melbourne and Metropolitan Board of Works Act 1958**, give notice under section 12 of the **Subordinate Legislation Act 1994**, as follows.

A regulatory impact statement (RIS) was prepared in relation to the proposed By-Law No. 2: Waterways and Drainage Protection and was advertised inviting public comment. Fifteen submissions were received, commenting on a number of issues relating to the RIS and the proposed by-law.

After considering these submissions, I have decided to recommend to the Governor in Council that the proposed By-Law No. 2: Waterways and Drainage Protection should be made with the following amendments.

For the purposes of clarity of application of the By-Law, a new term "vessel" has been defined under Clause 3 *Definitions*. Relevant changes are made to Clause 8 *Prohibited activities* to incorporate the term vessel. This change does not alter the applicability of the previous version of the By-Law as vessels were previously included under the definition of "vehicle". In addition, the term "jet ski" has been replaced with the term "motorised personal water craft", included in the definition of "vessel".
