Health Services Act 1988

AN ORDER PURSUANT TO SECTIONS 11, 33 AND 34 OF THE HEALTH SERVICES ACT 1988 IN RELATION TO BARWON HEALTH AND ITS BOARD OF MANAGEMENT

THE GOVERNOR IN COUNCIL pursuant to all enabling powers and section 11, section 33 and section 34 of the **Health Services Act 1988** (the Act) and on the recommendation of the Minister for Health, by this Order -

Declares, under section 11 of the Act, that section 33(3)(b) of the Act does not have effect in relation to Barwon Health until 1 November 1999 to the extent that the council of The University of Melbourne shall not be required to submit a panel of three names to the board of Barwon Health before the Minister may nominate a natural person to be a board member of Barwon Health under section 33(3)(b); and

Appoints, under sections 33(3)(b), 33(7) and 34(1) of the Act, Richard Graeme LARKINS to the board of management of Barwon Health until 31 October 1999; and

Specifies, under section 34(2)(b) of the Act, remuneration for Richard Graeme LARKINS as a board member as follows:

BOARD MEMBER	ANNUAL FEE FOR BOARD MEMBER
LARKINS Richard Graeme	\$25,000.00 p.a. when a board member is serving term as elected Chairperson of the board; \$12,000 p.a. at all other times

This Order in Council is to take effect from 18 August 1998.
