Road Safety (Vehicles) Regulations 1988

GENERAL PERMIT FOR THE OPERATION OF B-DOUBLES

Regulation 724 of the Road Safety (Vehicles) Regulations 1988 authorises the Roads Corporation, by notice in the Victoria Government Gazette, to allow vehicles and loads which exceed mass or dimension limits prescribed in the Regulations to be used on roads.

Regulation 819 of the Road Safety (Vehicles) Regulations 1988 authorises the Roads Corporation to approve a person to use, or cause or permit to be used, on a road a motor vehicle which is towing more than one other vehicle.

Under the above two Regulations, I, Geoff Kloot, delegate of the Roads Corporation, hereby amend the General Permit For The Operation Of B-doubles in the Victoria Government Gazette No. S111 on 16 September 1997, which allows B-doubles to be used on approved roads, as follows:

PART 4 - APPROVED ROADS

Clause 4.2 is amended to include the following unclassified roads where travel is allowed:

Warrnambool

McMeekin Road between Albert Street and Scott Street

Scott Street between McMeekin Road and Strong Street

This notice is effective from 19 August 1998 until 31 December 1999.
