# Subordinate Legislation Act 1994

PROPOSED GAMING MACHINE CONTROL (FEES) (AMENDMENT) REGULATIONS 1998

I, Roger M. Hallam, Minister for Gaming give notice under section 12 of the Subordinate Legislation Act 1994, that I have decided that the proposed Gaming Machine Control (Fees) (Amendment) Regulations be made, with amendment.

A Regulatory Impact Statement was prepared and advertised inviting public comment and submissions. One submission was received which supported the proposed Regulations.

During the public consultation process it was identified within the agency that one of the fees proposed in the Regulations, the fee of \$641 for renewal of premises approval, was not necessary.

Accordingly, I have decided to make the proposed Regulations, without the fee of \$641 for renewal of premises approval.
