Amendment S64

In Government Gazette G30 dated 30 July 1998 on page 2046, substitute all of the third paragraph with the following: The amendment modifies the condition applying to the use of land for Timber production within the Special Use-Brown Coal Areas zone (Clause 6P-1.1). The amendment allows land to be used for Timber production without the need for a planning permit, provided consultation with the holder of the mining rights under the relevant licence is undertaken and all of the land is used solely for the operation of the pulp and paper business in Gippsland.

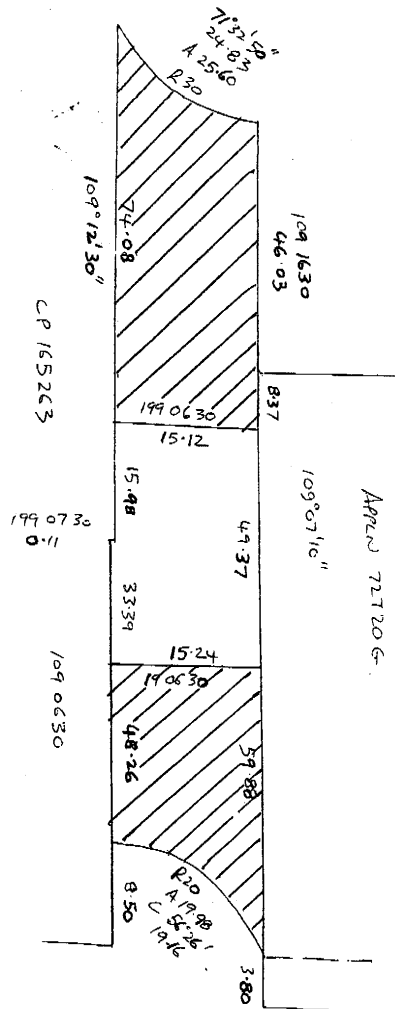

Addendum and Erratum

At its meeting on 27 August 1998 Frankston City Council resolved that there were no existing rights, powers or interests held by the Council, South East Water, Stratus Networks,

Telstra and United Energy or any other public authority in the road shown hatched on the plan contained in a notice of discontinuance of a road called Ross Smith Avenue published in the Victoria Government Gazette dated 16 April 1998 at page 830 ("the Gazettal") to be saved pursuant to section 207C of the **Local Government Act 1989** and that paragraph (iii) of the Gazettal no longer applied.

The land shown hatched on the plan below is substituted for the plan of Ross Smith Avenue which was published in the Gazettal.
