An authorised officer who finds a person contravening the provisions of this local law

may issue an infringement notice and impound any open liquor container in the person's possession. A person, if requested to do so, must give to an authorised officer an open liquor container which the authorised officer wishes to confiscate.

The local law came into operation on 24 August 1998.

LOCAL LAW NO. 8 - CONSUMPTION OF  
ALCOHOL IN PUBLIC PLACES LOCAL  
LAW

Notice is given that Yarra City Council resolved on 24 August 1998 to make a local law entitled "**Consumption of Alcohol in Public Places Local Law**" pursuant to section 119 of the **Local Government Act 1989**.

The purpose of the local law is to control consumption of liquor in public places during specified festivals and events as and when prescribed by Council. The local law aims to protect and minimise any risks to public safety, enhance the social environment and prevent public nuisances and anti social behaviour at specified festivals and events.

The general purport of the local law is to prohibit the consumption and possession of liquor in an open container by any person in a public place, in a prescribed area.

1. A prescribed area is an area specified by the Council for the purposes of the local law. In relation to a prescribed area, Council may, by public notice, declare a prescribed area by way of:
  - (a) description; or
  - (b) plan or map.
2. If the Council specifies an area to be a prescribed area, it must:
  - (a) publish a notice of that specification in the Government Gazette; and



- (b) ensure that a document describing the area, or plan or map showing the area, is available for inspection at the Council offices during normal office hours.
- 3. The declaration of a prescribed area may be made to operate:
  - (a) during a specified period of the day; or
  - (b) during a specified period of the year.
 If no period is specified, a prescribed area operates at all times, on all days each year.

Offences

- 4. A person who contravenes or fails to comply with any provision under this local law is guilty of an offence and is liable to a penalty. As an alternative to prosecution for an offence, a person may be served with an Infringement Notice. The local law specifies procedures for the payment of infringement notices served on persons guilty of an offence.
- 5. Any person consuming liquor, or in possession of liquor in an open container, in a public place in a prescribed area is guilty of an offence and subject to a penalty of \$200. An offence is not committed:-
  - (a) if the possession or consumption of alcohol is in a permitted alcohol consumption area; or
  - (b) "authorised premises" or "licensed premises" within the meaning of the **Liquor Control Act 1987**; or
  - (c) circumstances to which the **Liquor Control Act 1987** does not apply.
- 6. An authorised officer who finds a person contravening the provisions of this local law may impound any open liquor container in the person's possession. A person, if requested to do so, must give to an authorised officer an open liquor container which the authorised officer wishes to confiscate.

A copy of the local law may be inspected at the Richmond Town Hall, 333 Bridge Road, Richmond and the Collingwood Town Hall, 140 Hoddle Street, Abbotsford between the hours of 8.30 a.m. and 5.00 p.m. weekdays.

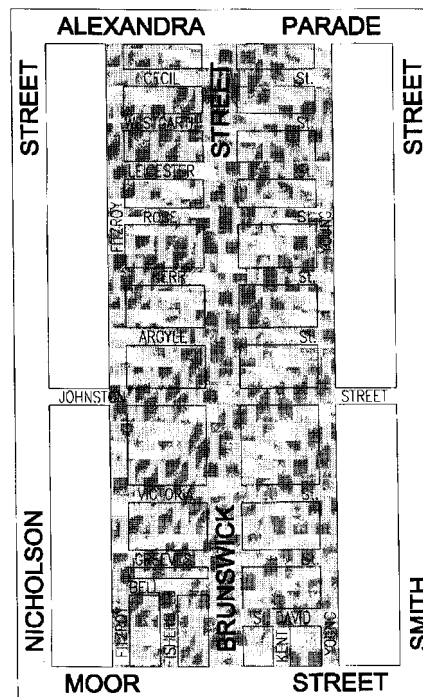

- (b) children whom the applicant is satisfied come on to the golf course to play competitive golf or to practice golf to enable them to play competitive golf.

This exemption does not limit the operation of section 62 or 66(2) of the Act or of any term or condition of the lease under which the Applicant occupies the Werribee Golf Course.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 16 September 2001.

The proposed regulations, which are to be made under the **Pay-roll Tax Act 1971** (the Act), will replace the existing Pay-roll Tax Regulations 1988.

The main objective of the proposed regulations is to prescribe matters needed to give effect to the **Pay-roll Tax Act 1971**.

The proposed regulations specify requirements for notices of deduction and advice of change in circumstances of taxpayers. They also:

- prescribe the rate of travelling and accommodation allowances;
- provide for calculation of the deduction; and
- prescribe certain activities under section 10(1)(e) of the Act.

The RIS contains an assessment of the costs and benefits of the proposed regulations and examines other options. The RIS concludes that the over-all benefits of the proposed regulations outweigh the costs to the community.

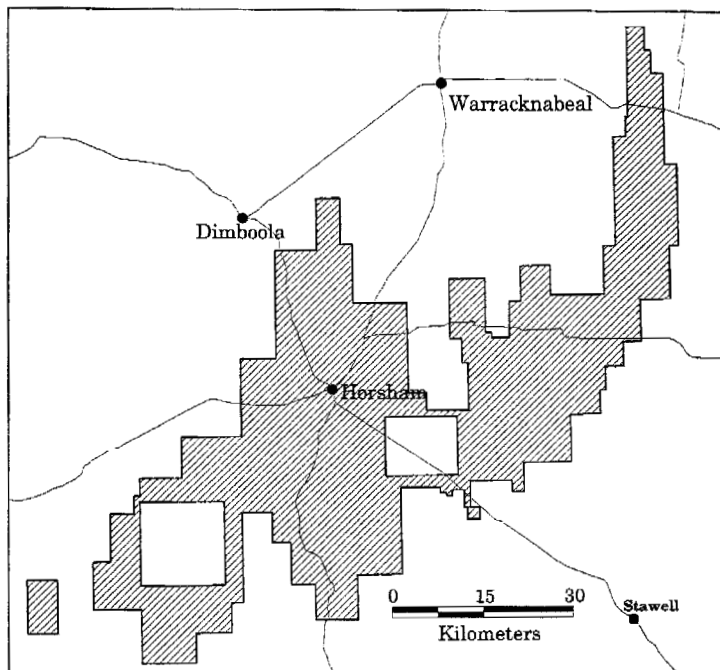

**Font size:**

Use 12 point (10 pitch) or larger.

**Font Style:**
