Environmental Local Law No. 2

Streets and Roads Local Law No. 3

to provide for the regulation of activities within the municipal district of the Council.

The purposes (objectives) of the respective proposed local laws are:

Environmental Local Law No. 2

The objectives of this local law are:-

- (a) to provide a safe and healthy environment in which the residents of the municipal district enjoy a quality of life that meets the general expectations of the community;
- (b) to prohibit, regulate and control activities which may be dangerous or unsafe or detrimental to the quality of life in an environment of the municipal district;
- (c) to facilitate the provision of general public services, health services, property services, recreational and cultural services and other services in a way which enhance the environment and quality of life in the municipal district;
- (d) to control nuisances and noise, odour and smoke emissions and other discharges to the environment which may adversely affect the enjoyment of life within the municipal district or the health, safety and welfare of persons within the municipal district;
- (e) in a way which is consistent with, and in furtherance of, the objectives specified on paragraphs (a) to (d) to prohibit, regulate and control activities and circumstances associated with:
 - (i) smoke emissions, particularly emission from burning material and from chimneys;
 - (ii) the use of recreational vehicles, particularly recreational vehicles which are not used on appropriate land or reserves or which emit excessive noise or air pollution;

- (iii) fire hazards;
 - (iv) dangerous and unsightly land;
 - (v) advertising, bill posting and junk mail;
 - (vi) camping;
 - (vii) circuses, carnivals and festivals;
 - (viii) water quality, including interference with water courses;
 - (ix) disposal of waste including behaviour associated with tips;
 - (x) animals, including animal numbers and the keeping and control of animals;
- (f) to provide for the peace, order and good government of the municipal district;
 - (g) to provide for the administration of the Council's powers and functions.

Streets and Roads Local Law No. 3

The principal objectives of this local law are to regulate the use of roads, in particular by:

- (a) providing for the management of the physical features of the road and adjacent properties in a manner which is consistent with the safety and convenience of people travelling on or using the road;
- (b) establish procedures for consultation to accompany major changes to traffic arrangements and the discontinuation of roads;
- (c) controlling the use of various types of vehicles and animals for the safety and convenience of road users;
- (d) providing for the preservation and protection of the Council's assets from damage which may be caused from extraordinary use of the roads;
- (e) controlling and regulating secondary activities on roads, including trading, the placing of goods and equipment, repairs to vehicles and parties, festivals, processions, busking and collections;
- (f) facilitating free and safe access for people with sight and movement impairment or disabilities;
- (g) providing for the safe and efficient management and control of parking on roads in the municipal district;

- (h) providing for the management and control of parking to cause minimum disruption, danger or nuisance to the user's of Council's parking facilities.

The general purpose of the proposed local laws include specifications of what form of regulations are proposed with a view to achieving the stated objectives in each local law.

It is proposed that certain activities may not be undertaken at all or without a permit, exemption or licence, allowing for conditions and fees to apply for permits or licences and conditions to apply for any exemptions.

It allows for the use of notices to comply in certain circumstances such as where conditions of a permit are not being met and provides for "authorised officers" to prosecute offences whether by the issue of infringement notices or by court procedures.

The proposed local laws set standards to be followed in exercising discretions.

The proposed local laws will apply to the whole of the municipal district except in those circumstances where its provisions apply to a localised area or allows for designation of further areas by resolution of Council with appropriate notice and signposting.

The aim is for better regulation of activities within the municipal district and on any foreshore with a view to consideration of the welfare of the whole community.

Copies of the proposed local laws may be inspected at or obtained from the Service Centres at Melville Street, Numurkah; Station Street, Cobram; Belmore Street, Yarrawonga or Council's agencies at Barr Street Tungamah (General Store) or Blake Street, Nathalia (Post Office).

Any person requesting to be heard in support of a written submission is entitled to appear before a meeting of Council either personally or by a representative acting on that person's behalf and will be notified of the time and date of that hearing.

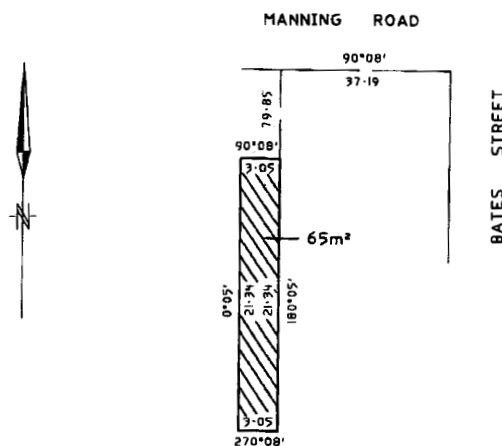

The clients are people who need assistance with everyday tasks including washing, showering, toileting, dressing, grooming, eating and drinking, exercising, medication compliance, personal development etc. Some clients also need assistance with basic household support including general house cleaning, dusting, vacuuming, washing, etc. Home and personal carers provide personal and intimate care to clients.
- The carer is also assisting the client in the areas of transportation, banking and shopping services.
- The transportation services provided by AHCS involve a carer taking a client to a medical appointment or to a recreational engagement.
- The banking services provided by AHCS involve a carer accompanying a client to a bank to enable the client to carry out his or her banking.
- The shopping services provided by AHCS involve a carer collecting a client from his or her home, accompanying the client to assist him or her with shopping, returning with the client to his or her home and unpacking the client's shopping and ensuring the client is comfortably settled. Where a client is incapable of leaving his or her home, a carer may do a client's shopping by following a list provided by a client.
- AHCS selects the carers for each client and takes into account the requirements of its clients and attempts to meet those requirements. AHCS clients who are sick, disabled or elderly may ask that the carer be someone of their own sex, age or religious belief.

- There are approximately 30 qualified Aromatherapists operating in Melbourne. Some of these services are available to men and women.
- Aromatherapy is the treatment of the body (physical and emotional) using essential oils obtained from plants and is performed by massaging the body using these oils and by bathing in these oils, and by inhaling or burning them in the home. Regular aromatherapy massages will bring about a dramatic improvement in well being and health and a person feels more relaxed, less stressed and has more peace of mind. The treatments are given by massaging the full body with the client undressed down to their underwear.
- The applicant provides the service in her home and there will only be one client present at a time.
- Female clients will feel more comfortable in accessing this service if they know that there will be no chance that male clients will be visiting the applicant's home before or after them, or be waiting for their appointments while female clients will be receiving aromatherapy in a state of undress.

- The applicant lives alone and out of concern for her personal safety, prefers to offer these services from her home to female clients only.

The Tribunal grants an exemption from the operation of Sections 42, 100 and 195 of the **Equal Opportunity Act 1995**, to enable the applicant to advertise for and provide Aromatherapy to women only. This exemption is granted for 3 years and is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 16 September 2001.

- (3) If a resident rescinds a contract under these paragraphs the resident is entitled to the refund of all moneys paid by the resident under the contract, except for the sum of \$100 or 0.2 percentum of the in-going contribution paid by the resident (whichever is the greater) which may be retained by the owner.
- (4) A contract to which these paragraphs apply must contain a conspicuous notice advising the resident that the resident may before the end of 21 clear business days after the resident signs the contract give notice that the resident wishes to terminate the contract.
- (5) If a contract to which these paragraphs apply does not contain the notice required by paragraph 2(4) a resident may rescind the contract.
- (6) In these paragraphs "business day" means a day which is not a holiday within the meaning of section 44(3) of the **Interpretation of Legislation Act 1984**.
3. Section 33 upon condition that the information which would have been required to be presented to the annual meeting, is delivered to the residents of the village (or their representatives) once a year, and an annual meeting is held if a written request is received from more than 20% of the residents in the village (or their representatives).
4. Sub-section (1) of section 34 upon condition that the information which would have been required to be prepared and presented at the annual meeting is prepared and delivered to residents of the village (or their representatives) once a year.
5. Sub-section (3) of section 34 upon condition that the financial statement which would have been required to be presented at an annual meeting is prepared and delivered to the residents of the village in accordance with paragraph 4.
6. Sub-section (4) of section 34 upon condition that if a written request is received from 25% of the residents in the village (or their representatives), the financial statement referred to in paragraph 4 will be audited by a registered company auditor.
7. Section 38 upon condition that no resident in the village is required to pay a maintenance charge which exceeds an amount calculated pursuant to any current agreement between the manager and the Commonwealth in accordance with the **Aged or Disabled Persons Care Act 1954** and/or the **Aged Care Act 1997** as amended from time to time.
8. And upon conditions that:
- (a) a copy of this declaration is given to each prospective resident at the time such resident is given the residence documents relating to the village and to residents presently residing at the village;

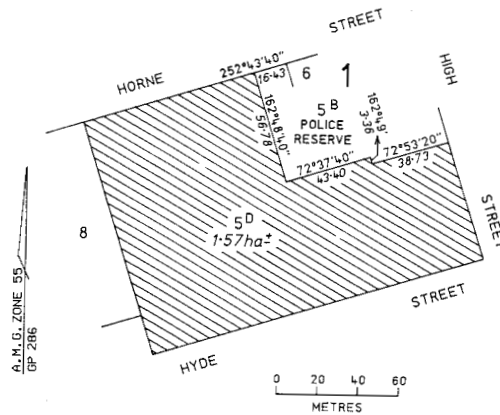

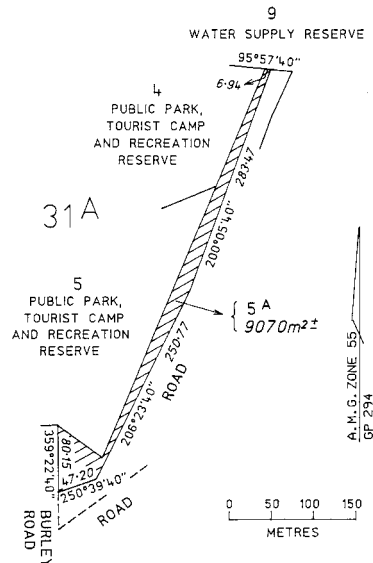

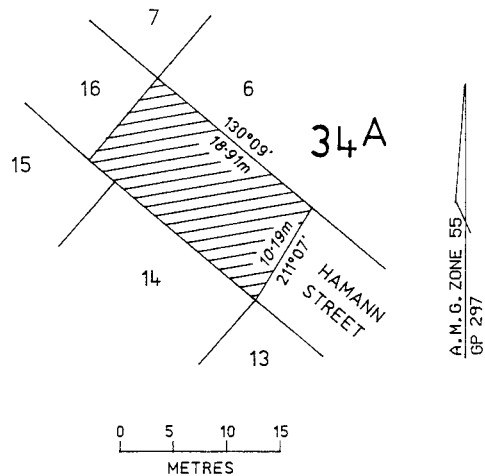
