1. *Objective*

The objective of this Notice is to repeal the Fisheries Notice No. 3/1998 - "Fisheries (Australian Pilchard Prohibition) Notice 1998" - which prohibited the taking, landing, processing, selling or possession of Australian pilchard from Victorian waters.

2. *Authorising provision*

This Notice is made under section 152 of the **Fisheries Act 1995**.

3. *Repeal*

The Fisheries (Australian Pilchard Prohibition) Notice 1998 is repealed.
