Melbourne City Link Act 1995 ORDER EXEMPTING CHURCH STREET BRIDGE FROM THE OPERATION OF THE HERITAGE ACT 1995

The Minister for Planning and Local Government makes the following Order:

1. *Purposes*

The purposes of this Order are —

- (a) to exempt the northern span of the Church Street Bridge, Richmond from the application of the **Heritage Act 1995** for the purposes of the carrying out of works required for the Melbourne City Link Project; and
- (b) to impose conditions on works and development of that site to maintain as far as practicable the character, appearance and heritage value of that site.

2. *Authorising provisions*

This Order is made under section 65 of the **Melbourne City Link Act 1995**. The exempted site is part of the Project Area for the purposes of that Act.

3. *Definition*

In this Order —

“**Church Street Bridge**” means the structure known as the Church Street Bridge which connects Church Street, Richmond with Chapel Street, South Yarra;

“**City Link works**” means works or developments authorised under the **Melbourne City Link Act 1995** for the purposes of the Project within the meaning of that Act;

“**the North span**” means that part of the Church Street Bridge, which is within the Project Area within the meaning of the **Melbourne City Link Act 1995**.

4. *Exemption from operation of the Heritage Act 1995*

The North span is exempted from the operation of the **Heritage Act 1995** from

the date of publication of this Order in the Government Gazette until 31 December 1999 or until this Order is earlier revoked.

5. *No works on North span other than authorised City Link works*

- (1) This Order is made subject to the condition that any City Link works carried out on the North span must be carried out to the satisfaction of the Minister.
- (2) Without limiting the generality of subclause (1), City Link works carried out on the North span are subject to the following conditions:
 - (a) Modification or rebuilding of the supporting arches of the North span must be carried out to the satisfaction of the Minister.
 - (b) Bridge surfaces must be finished to imitate a cement render to the satisfaction of the Minister.
 - (c) Missing or damaged cartouches or medallions must be reinstated or repaired to the satisfaction of the Minister.
