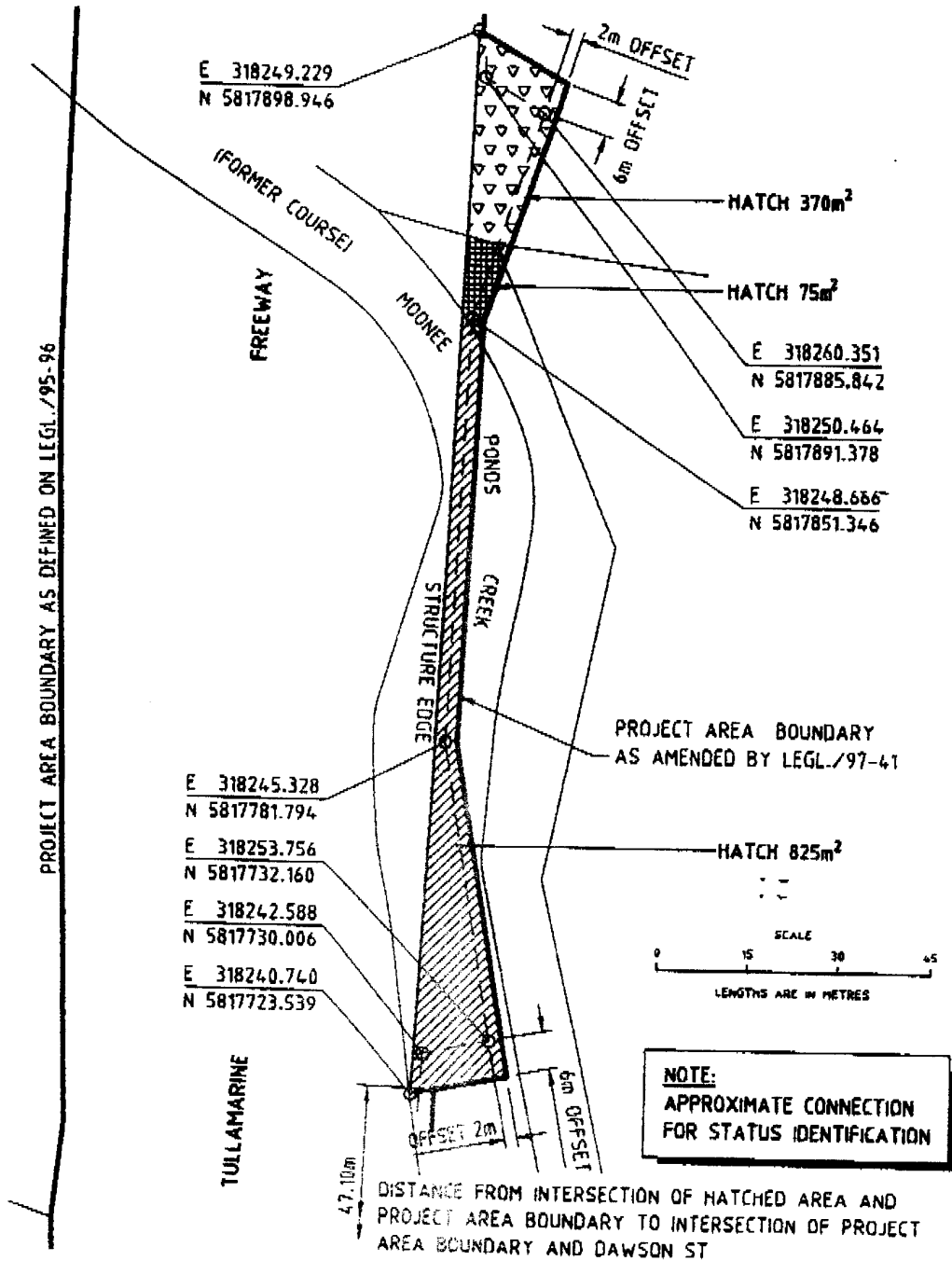

**NOTICE PURSUANT TO SECTION 41**

Pursuant to section 41 of the **Melbourne City Link Act 1995** ("the Act"), the Melbourne City Link Authority elects to use the procedures provided under sections 42 and 43 of the Act in the acquisition pursuant to section 38 of the Act of the land which is part of the project area (as defined by section 7 of the Act). The land, the subject of the election, is in the specified part of the project area, being that area east of the Tullamarine Freeway, and shown triangle hatched on the plan below.
