Melbourne City Link Act 1995 NOTICE TO PUBLIC BODIES


In accordance with section 46 of the **Melbourne City Link Act 1995** ("the Act") notice is given of the proposal to issue a licence or licences under section 56 of the Act in respect of the land described in the Schedule below.

All public bodies (as defined in section 3 of the Act) whose interests, works or functions may be affected by a licence are requested to advise the Melbourne City Link Authority in writing of those interests, works or functions within 7 days of publication of this notice in the Government Gazette.

Responses should be forwarded directly to the Melbourne City Link Authority at Level 13, Nauru House, 80 Collins Street, Melbourne 3000 or to P.O. Box 18185, Collins Street East, Melbourne 8003, for the attention of the Director Property and Public Bodies.

MINISTERIAL DIRECTION UNDER SECTION 61 OF THE **FISHERIES ACT 1995**

- I, Patrick McNamara, Minister for Agriculture, and Resources, give direction that for the classes of access licences listed in the schedule below:-
 - 1. That no access licences are to be transferred.
 - 2. That no person other than the holder of the access licence shall be recorded on the licence to carry out any fishing activities authorised by the licence under sections 39(1) and 39(2) of the **Fisheries** Act 1995.

Management of Bay and Inlet Fisheries in Victoria is currently being reviewed. On completion of the review, Ministerial Directions for Bay and Inlet Fisheries will be amended to reflect any decisions made by the Government in respect of Bay and Inlet Fisheries.

This Direction will remain in effect until 30 June 1999 or until sooner revoked.
