TOW TRUCK DIRECTORATE OF VICTORIA

I, Garry Ellis, Director, Tow Truck Directorate of Victoria, pursuant to Section 183A of the **Transport Act 1983**, declare that I have determined the following area to be a controlled area for the purposes of Division 8 of Part 6 of the said Act.

1. That area firstly bounded by a notional line drawn from the coastline at the Mornington Jetty along Schnapper Point Drive, Main Street and Mornington-Tyabb Road to its intersection with Yuilles Road, in a northerly direction along Yuilles Road to its intersection with the railway line, in an easterly direction along the railway line to its intersection with Moorooduc Highway, in a northerly direction along Moorooduc Highway to its intersection with Robinsons Road, along Robinsons Road to its intersection with Western Port Highway, in a northerly direction along Western Port Highway to its intersection with Glasscocks Road, in an easterly direction along Glasscocks Road to its intersection with South Gippsland Highway, in a northerly direction along South Gippsland Highway to a point at which it is crossed by the GPU Powernet Pty Ltd electricity transmission line, in a north easterly and northerly direction along the transmission line to its intersection with Shrives Road, in an easterly direction along Shrives Road to its intersection with Centre Road, in an easterly direction along Centre Road and Fullard Road to its intersection with Narre Warren-Cranbourne Road, in a northerly direction along Narre Warren-Cranbourne Road and Narre Warren North Road to its intersection with Belgrave-Hallam Road, in a northerly direction along Belgrave-Hallam Road to its intersection with Mountain Flat Road, along Mountain Flat Road to its intersection with Wellington Road, in an easterly direction along Wellington Road to its intersection with Cardinia Creek Road, along Cardinia Creek Road to its terminus, in a north-easterly

direction to the terminus of Wong Hee Road West, along Wong Hee Road West to its intersection with Kilvington Drive, along Kilvington Drive to its intersection with Belgrave-Gembrook Road, in a westerly direction along Belgrave-Gembrook Road to its intersection with Wellington Road, in a northerly direction to the intersection of Trumpington Grove and Ridge Road, in a northerly direction to the intersection of Kallista-Emerald Road and Waterfield Road, along Waterfield Road and Rankins Road to its intersection with David Hill Road, in a northerly direction along David Hill Road to its intersection with Vika Avenue, along Vika Avenue to its intersection with Allandale Road, in a north-westerly direction to the terminus of Emerald Creek Road, along Emerald Creek Road to its intersection with McAllister Road, along McAllister Road to its intersection with Old Emerald Road, in a westerly direction along Old Emerald Road to its intersection with Anderson Road, along Anderson Road to its intersection with Monbulk Road, in a north-easterly direction along Monbulk Road to its intersection with Monbulk-Seville Road, along Monbulk-Seville Road to its intersection with Link Road, in a northerly direction to the intersection of Parker Road and Graham Road, along Graham Road to its intersection with Queens Road, in a south-westerly direction along Queens Road to its intersection with Lewis Road, along Lewis Road to its intersection with Hunter Road, in an easterly direction along Hunter Road to its intersection with McKillop Road, along McKillop Road to its intersection with Forest Road, along Forest Road and Bailey Road to its intersection with Seth Place, in a northerly direction to the intersection of Warburton Highway and Boundary Road, along Boundary Road to the point at which it is crossed by the GPU Powernet Pty Ltd electricity transmission line, in a north-westerly direction along the transmission line to the point at which it crosses Eltham-Yarra Glen Road, in a southerly direction along Eltham-Yarra Glen Road and Main

Road to its intersection with Wattletree Road, along Wattletree Road and Ryans Road to the point at which it is crossed by the GPU Powernet Pty Ltd electricity transmission line, in a north-westerly direction along the transmission line to its terminal station at South Morang, in a northerly direction to the terminus of Gordons Road, in a northerly direction to the intersection of Regent Street and Sackville Street, in a northerly direction along Sackville Street to its intersection with Bridge Inn Road, in a northerly direction to the intersection of Wilkes Court and Masons Road, in a westerly direction along Masons Road to its intersection with Epping Road, in a northerly direction along Epping Road to its intersection with Summerhill Road, along Summerhill Road and Mount Ridley Road to its intersection with Konagaderra Road, in a westerly direction to the terminus of Feehans Road, along Feehans Road to its intersection with Wildwood Road, in a north-westerly direction to the terminus of Clark Court, along Clark Court to its intersection with Melbourne-Lancefield Road, in a westerly direction to the right angled bend on Settlement Road situated 2 kilometres east of its intersection with Riddell Road, in a westerly direction along Settlement Road and Settlement Road West to its terminus, in a southerly direction to the intersection of Dalrymple Road and Mundy Road, along Mundy Road and Couangalt Road to its intersection with Berrie Road, along Berrie Road to its intersection with Millett Road, in a westerly direction along Millett Road to its intersection with Black Hill Road, in a southerly direction along Black Hill Road to its intersection with Diggers Rest-Coimadai Road, in a south-westerly direction along Diggers Rest-Colmadai to its intersection with Holden Road, along Holden Road to its intersection with Leakes Road, along Leakes Road to its intersection with Greigs Road, in a westerly direction along Greigs Road to its intersection with Downing Road, along Downing Road to its intersection with Dohertys Road, in an easterly direction along Dohertys Road to its intersection with Shanahans Road, in a southerly direction

along Shanahans Road to a point at which it is crossed by the GPU Powernet Pty Ltd electricity transmission line, in a westerly and south-westerly direction along the transmission line to a point at which it crosses the Little River, in a southerly direction along the western bank of the Little River to the coast, secondly by the coastline from the Little River to the Mornington Jetty.

2. The line drawn as projected in clause 1 shall be deemed to be drawn twenty metres beyond and parallel to the right hand edge of the carriageway, road, street, drive, court, or lane referred to in such clause.

Under and for the purposes of Item 1 of Schedule 3 to the WorkCover Insurance Premiums Order (No. 6) 1998/99, the Victorian WorkCover Authority has determined that the values of F_0^c , F_1^c and F_2^c , for the purposes of calculating the Experience Factor E, for a period of coverage of a workplace, are respectively the relevant numbers specified in the following Table, opposite the authorised agent which calculated the costs of claims of the workplace:
