## **Melbourne City Link Act 1995**

### NOTICE OF DECLARATION OF EXTENSION ROAD

I, Robert Maclellan, Minister for Planning and Local Government and Minister administering the **Melbourne City Link Act 1995** ("the Act"), in accordance with section 93H (2) of the Act, give notice that I have today made a declaration under section 93H (1) of the Act. A copy of that declaration is printed with this notice.

By operation of the definition of "Extension road" in section 3 of the Act, the land the subject of the declaration is the Extension road.

On the publication of this notice in the Government Gazette, by operation of section 93H (3) of the Act, the road specified in the declaration is deemed to be-

- a. a declared road within the meaning of the **Transport Act 1983**; and
- b. a road open to and for use by the public for passage with vehicles; and
- c. a highway within the meaning of the **Road Safety Act 1986**.

The declaration applies to the land comprised in the Crown Allotments listed in the Schedule to the declaration, as shown on the plan LEGL./99-177 lodged at the Central Plan Office of the Department of Natural Resources and Environment. Copies of this plan are available from the Land and Survey Information Centre, Department of Natural Resources and Environment, Ground Floor, 456 Lonsdale Street, Melbourne, 3000.

An overview plan of the Exhibition Street Extension is also published with this notice for information purposes only.

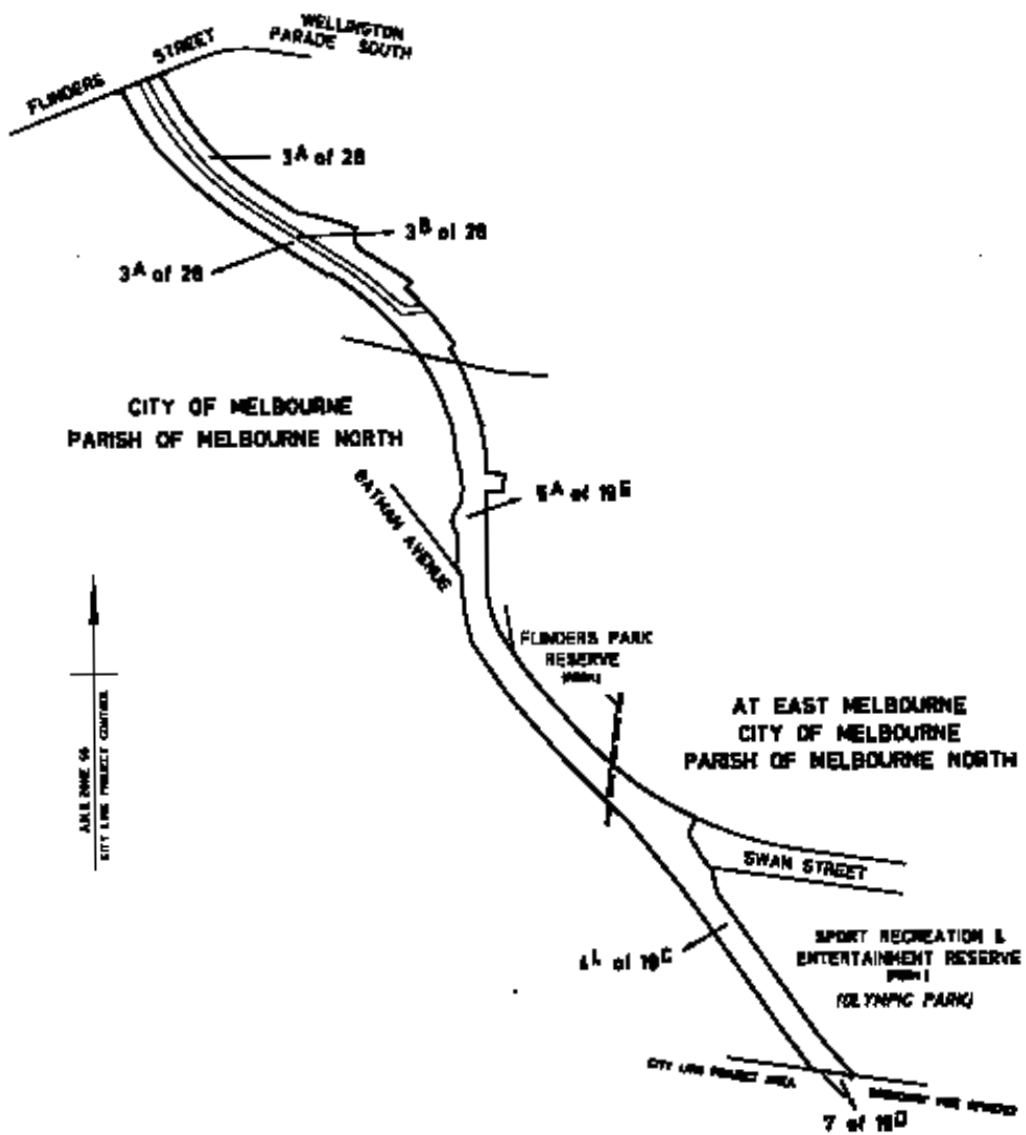
