ALTERATION OF WARD BOUNDARIES OF DELATITE SHIRE COUNCIL

Order In Council

The Governor in Council hereby directs that:

- a) Under Section 220S (1)(a) of the **Local Government Act 1989**, this Order comes into operation on the day it is published in the Government Gazette; and
- b) Under Section 220Q (k) and (m) of the Local Government Act 1989, on the day this Order comes into operation the ward boundaries and names of wards of the Delatite Shire Council shall be fixed as described in the Schedule to this Order.

SCHEDULE 1

MOKOAN RIDING

Commencing on the western boundary of the Shire at the Hume Freeway; thence north-easterly by the Hume Freeway to the Benalla-Warrenbayne Road; thence northerly by that road to the Baddaginnie-Benalla Road; thence north-easterly by that road to Cemetery Road; thence northerly and westerly by that road to Steele Road; thence northerly by that road to Goomalibee Road; thence easterly by that road to Nursery Lane; thence northerly by that lane to the Broken River; thence south-easterly by that river to the south-western angle of allotment 5 section D Parish of Benalla; thence generally easterly by the southern boundaries of that allotment and allotments 4, 3 and 2 and northerly by the eastern boundary of allotment 2 to Roe Street; thence easterly by that street to the North Eastern Railway: thence north-easterly by that railway to the Benalla-Yarrawonga Road: thence south-easterly by that road. Pearson Road and a line in continuation to the Hume Freeway; thence south-westerly by that freeway to Kilfeera Road; thence south-easterly by that road to the Upper Lurg Road, being a point on the eastern boundary of the shire, and thence northerly, westerly and southerly by the shire boundary to the point of commencement.

BENALLA CIVIC RIDING

Commencing on the Hume Freeway at

Holland Creek; thence generally north-westerly by Holland Creek to the Broken River, thence northerly by that river to Bridge Street West; thence easterly by that street to the eastern bank of Lake Benalla; thence north-westerly by that bank to a point in line with Benalla Street; thence north-easterly by a line and Benalla Street to Nixon Street; thence north-westerly by that street to MacKellar Street; thence easterly by that street to Salisbury Street; thence northerly by that street, Salisbury Street North and a line in continuation to the North Eastern Railway; thence north-easterly by that railway to the Benalla-Yarrawonga Road; thence southeasterly by that road, Pearson Road and a line in continuation to the Hume Freeway, and thence south-westerly by that freeway to the point of commencement.

BENALLA GARDENS RIDING

Commencing on the Baddaginnie-Benalla Road at Cemetery Road; thence northerly and westerly by Cemetery Road to Steele Road; thence northerly by that road to Goomalibee Road; thence easterly by that road to Nursery Lane; thence northerly by that lane to the Broken River; thence south-easterly by that river to the south-western angle of allotment 5, section D, Parish of Benalla; thence generally easterly by the southern boundaries of that allotment and allotments 4, 3 and 2 and northerly by the eastern boundary of allotment 2 to Roe Street; thence easterly by that street to the North Eastern Railway; thence north-easterly by that railway to a point in line with Salisbury Street North; thence southerly by a line, Salisbury Street North and Salisbury Street to MacKellar Street; thence westerly by that street to Nixon Street; thence south-easterly by that street to Benalla Street; thence south-westerly by that street and a line in continuation to the eastern bank of Lake Benalla; thence south-easterly by that bank to Bridge Street West; thence south-westerly by that street and the Baddaginnie-Benalla Road to the point of commencement.

BENALLA HERITAGE RIDING

Commencing on the Hume Freeway at the Benalla-Warrenbayne Road; thence northerly by the Benalla-Warrenbayne Road to the Baddaginnie-Benalla Road; thence north-easterly by that road and Bridge Street West to the Broken River; thence generally southerly by that river to a point in line with Evan James Drive; thence westerly by a line and that drive to the Midland Highway; thence southerly by that highway to the Hume Freeway, and thence generally westerly by that freeway to the point of commencement.

SWANPOOL RIDING

Commencing on the western boundary of the Shire at the Hume Freeway; thence north-easterly by the Hume Freeway to the Midland Highway; thence northerly by that highway to Evan James Drive; thence easterly by that drive and a line to the Broken River; thence north-easterly by that river to Holland Creek; thence easterly by that creek to the Hume Freeway; thence north-easterly by that freeway to Kilfeera Road; thence south-easterly by that road to Upper Lurg Road being a point on the eastern boundary of the Shire; thence southerly and south-easterly by that boundary to the southern boundary of the Parish of Cambatong; thence westerly by that boundary to the Broken River; thence westerly by that river to Old Tolmie Road; thence south-westerly by that road to Graves Road; thence south-westerly by that road to McLeod Road; thence north-westerly by that road to the north-eastern angle of Lot 2 on Plan of Subdivision 73946; thence north-westerly and south-westerly by the north-eastern and north-western boundaries of that lot to the northern boundary of Lot 1 on Plan of Subdivision 91412; thence westerly by that boundary and the northern boundary of Lot 2 to the eastern boundary of Lot 6 on Plan of Subdivision 3180; thence northerly and westerly by the eastern and northern boundaries of Lot 6 to the road forming the western boundary of that lot; thence northerly and westerly by that road and further westerly by Lakins Road to Withers Road; thence southerly by that road to the Maroondah Highway; thence westerly by that highway to the Midland Link Highway; thence north-easterly by that highway and northerly by the Midland Highway to Johnstons Road; thence westerly by that road to the Barjarg-Glen Creek Road; thence north-easterly by that road to Harper Road; thence north-westerly by that road and Barjarg Road to the northern boundary of the Parish of Tallangallook; thence westerly by

that boundary to the western boundary of the Shire, and thence generally northerly by the shire boundary to the point of commencement.

ALPINE RIDING

Commencing on the eastern boundary of the Shire at the southern boundary of the Parish of Cambatong: thence westerly by that parish boundary to the Broken River; thence westerly by that river to Old Tolmie road; thence south-westerly by that road to Graves Road: thence north-easterly by that road to Scully Road; thence southerly by that road and Stoney Road to Pollards Road; thence easterly by that road to Mt. Buller Road; thence south-easterly by that road to the Boorolite-Chapel Hill Road: thence southerly and south-westerly by that road to Delatite Road; thence north-westerly by that road to the Mansfield-Woods Point Road; thence southerly by that road to the Piries-Goughs Bay Road; thence south-westerly by that road to south-western angle of Lot 1 on Plan of Subdivision 117670; thence easterly by the southern boundary of that lot and Lots 2 and 3 to a point in line with the western boundary of allotment 167A, Parish of Howqua West; thence southerly by a line and the western boundary of that allotment and south-easterly by the south-western boundaries of that allotment and allotment 167 to the north-western boundary of allotment 169; thence south-westerly by that boundary to the Lake Eildon Water Boundary; thence following this boundary generally in a south to south-easterly direction to the Howqua Arm Entrance; thence south-westerly and south-easterly to the entrance of the Goulburn River at Jamieson; thence generally north-westerly, south-westerly and south-easterly to the Big River Arm entrance being a point on the south-western boundary of the Shire, and thence generally south-easterly, north-easterly and north-westerly by the shire boundary to the point of commencement.

MANSFIELD CENTRAL RIDING

Commencing on the Maroondah Highway at Paps Lane; thence south-easterly by the Maroondah Highway to Withers Lane; thence northerly by that road to Lakins Road; thence easterly by that road and further easterly by a road to the northern boundary of Lot 6 on Plan of Subdivision 3180; thence easterly and southerly by the northern and eastern boundaries

of that lot to the north-western angle of Lot 2 on Plan of Subdivision 91412; thence easterly by the northern boundary of that lot and Lot 1 to the western boundary of Lot 2 on Plan of Subdivision 73946; thence north-easterly and south-easterly by the north-western and north-eastern boundaries of that lot to McLeod Road; thence south-easterly by that road to Graves Road; thence north-easterly by that road to Scully Road; thence southerly by that road and Stoney Road to Pollards Road; thence easterly by that road to Mt. Buller Road; thence south-easterly by that road to the Boorolite-Chapel Hill Road; thence southerly and south-westerly by that road to Delatite Road; thence north-westerly by that road to the Mansfield-Woods Point Road; thence northerly by that road to Ogilivies Road; thence westerly by that road to Monkey Gully Road; thence south-westerly by that road to the Howes Creek-Goughs Bay Road; thence north-westerly by that road and northerly and north-easterly by the Mansfield-Howes Creek Road to the most southern angle of Lot 1 on Plan of Subdivision 7501: thence north-westerly by the south-western bounday of that lot to Fords Creek; thence westerly by that creek to the Lake Eildon Water Boundary; thence north-westerly and south-westerly by that water boundary to a point in line with Paps Road, and thence northerly by a line and Paps Road to a point of commencement.

LAKELAND RIDING

Commencing at a point on the western boundary of the Shire at the northern boundary of the Parish of Tallangallook; thence easterly by the parish boundary to Barjarg Road; thence south-easterly by Barjarg Road and Harper Road to the Barjarg-Glen Creek Road; thence south-westerly by that road to Johnstons Road; thence easterly by that road to the Midland Highway; thence southerly by that highway to the Midland Link Highway; thence south-westerly by that highway to the Maroondah Highway; thence easterly by that highway to Paps Lane; thence southerly by that lane and a line in continuation to the Lake Eildon Water Boundary; thence north-easterly and south-easterly by that Water boundary to Fords Creek; thence easterly by that creek to western boundary of Lot 1 on Plan of Subdivision 7501; thence south-easterly by the south-western boundary of that lot to the Mansfield-Howes Creek Road; thence

south-westerly by that road and south-easterly by the Howes Creek-Goughs Bay Road to Monkey Gully Road; thence north-easterly by that road to Ogilvies Road; thence easterly by that road to the Mansfield-Woods Point Road; thence southerly by that road to the Piries-Goughs Bay Road; thence south-westerly by that road to south-western angle of Lot 1 on Plan of Subdivision 117670; thence easterly by the southern boundary of that lot and Lots 2 and 3 to a point in line with the western boundary of allotment 167A, Parish of Howqua West; thence southerly by a line and the western boundary of that allotment and south-easterly by the south-western boundaries of that allotment and allotment 167 to the north-western boundary of allotment 169; thence south-westerly by that boundary to the Lake Eildon Water Boundary; thence following this boundary generally in a south to south-easterly direction to the Howqua Arm Entrance; thence south-westerly and south-easterly to the entrance of the Goulburn River at Jamieson; thence generally north-westerly, south-westerly and south-easterly to the Big River Arm entrance being a point on the south-western boundary of the Shire, and thence north-westerly and north-easterly by the shire boundary to the point of commencement.

NEPEAN WARD

RYE BEACH WARD

Commencing on the shore of Port Phillip Bay at Chinamans Creek being a point on the north-western boundary of the Shire; thence southerly by Chinamans Creek to Eastbourne Road; thence easterly by that road to Illaroo Street; thence southerly by that street to Allambi Avenue; thence south-westerly by that avenue to Coleman Crescent; thence south-easterly and easterly by that crescent to Boneo Road; thence southerly by that road to the centreline of the proposed Mornington Peninsula Freeway reservation; thence south-westerly by the centre of the proposed Freeway reservation to Truemans Road; thence northerly by that road to Booran Parade; thence westerly by that parade to Mathis Avenue; thence westerly by that avenue and Brights Drive to Weeroona Street; thence southerly by that street to the centreline of the proposed Mornington Peninsula Freeway reservation; thence westerly by the centre of the proposed Freeway reservation to Dundas Street; thence southerly by that street to Browns Road; thence north-westerly by that road to Francis Street; thence northerly by that street to Melbourne Road; thence north-easterly by that road to Bimbiang Crescent; thence westerly by that crescent to Whitecliffs Road; thence northerly by that road and a line in continuation to the shore of Port Phillip Bay, and thence easterly by the shore of Port Phillip Bay to the point of commencement.

ROSEBUD WARD

Commencing on the shore of Port Phillip Bay at point in line with the continuation of Farey Avenue being a point on the north-western boundary of the Shire; thence south-easterly by a line to Latrobe Parade at Farey Avenue; thence south-westerly and southerly by Latrobe Parade to north-western angle of Arthurs Seat State Park; thence southerly by the western boundary of the Parish of Kangerong and further southerly by a line in continuation to Waterfall Gully Road; thence southerly and westerly by that road to Goolgowie Street; thence southerly and south-westerly by that street to Duells Road; thence south-easterly by that road to the southern boundary of crown allotment 30H Parish of Wannaeue; thence westerly by that boundary to Jetty Road; thence north-westerly by that road to Old Cape Schanck Road; thence south-westerly by that road to a point in line with the continuation of Hiscock Road; thence westerly by a line to Boneo Road at Hiscock Road; thence northerly by that road to Coleman Crescent: thence westerly and north-westerly by that crescent to Allambi Avenue: thence north-easterly by that avenue to Illaroo Street: thence north-westerly and northerly by that street to Eastbourne Road; thence westerly by that road to Chinamans Creek; thence northerly by that creek to the shore of Bass Strait, and thence north-easterly by that shore to the point of commencement.

MOUNT MARTHA WARD

Commencing on the shore of Port Phillip Bay at point in line with the continuation of Bentons Road being a point on the north-western boundary of the Shire; thence south-easterly by a line and Bentons Road to the Moorooduc Highway; thence south-westerly by that highway and the Mornington Peninsula Freeway to the Bittern-Dromana Road; thence westerly by that road and a line in continuation the shore of Port Phillip Bay, and thence north-easterly by that shore to the point of commencement.

MORNINGTON WARD

Commencing on the shore of Port Phillip Bay at point in line with the continuation of Bentons Road being a point on the north-western boundary of the Shire; thence south-easterly by a line and Bentons Road to the Moorooduc Highway; thence north-easterly by that highway to Wooralla Drive; thence north-westerly by that drive to the Mornington Tourist Railway Line; thence westerly by that tourist railway line to a point in line with Oakbank Road; thence north-westerly by a line and Oakbank Road to the Nepean Highway; thence north-easterly by that highway to the eastern boundary of the Mornington Country Golf Club; thence northerly by that boundary to the Manmangur Creek; thence northerly by that creek to the shore of Port Phillip Bay, and thence south-westerly by that shore to the point of commencement.

MOUNT ELIZA WARD

Commencing on the north-eastern boundary of the shire at the junction of Humphries Road and the Moorooduc Highway: thence south-westerly by the Moorooduc Highway to Wooralla Drive; thence north-westerly by that drive to the Mornington Tourist Railway Line; thence westerly by that tourist railway line to a point in line with Oakbank Road; thence north-westerly by a line and Oakbank Road to the Nepean Highway; thence north-easterly by that highway to the eastern boundary of the Mornington Country Golf Club; thence northerly by that boundary to the Manmangur Creek; thence northerly by that creek to the shore of Port Phillip Bay being a point on the boundary of the Shire, and thence north-easterly and south-easterly by the shire boundary to the point of commencement.

FINGAL WARD

Commencing on the shore of Western Port at a point in line with Beach Road Shoreham; thence north-westerly by a line and Beach Road to the Frankston-Flinders Road; thence northerly and north-easterly by that road to Point Leo Road; thence north-westerly by that road to a point in line with Tonkins Road; thence northerly by a line, Tonkins Road and further northerly by a line to Kentucky Road; thence westerly and north-westerly by that road to Red Hill Road; thence northerly by that road to the Bittern-Dromana Road; thence north-westerly by that road to the road forming the northern boundary of allotment 24 Parish of Kangerong; thence easterly by that road to a point in line with Bulldog Creek Road; thence northerly by a line and Bulldog Creek Road to Ellerina Road; thence westerly by that road and a line in continuation to the Mornington Peninsula

Freeway; thence south-westerly by that freeway to the Bittern-Dromana Road; thence westerly by that road and a line in continuation the shore of Port Phillip Bay; thence south-westerly by that shore to a point in line with the continuation of Farey Avenue; thence south-easterly by a line to Latrobe Parade at Farey Avenue; thence south-westerly and southerly by Latrobe Parade to north-western angle of Arthurs Seat State Park; thence southerly by the western boundary of the Parish of Kangerong and further southerly by a line in continuation to Waterfall Gully Road; thence southerly and westerly by that road to Goolgowie Street; thence southerly and south-westerly by that street to Duells road; thence south-easterly by that road to the southern boundary of crown allotment 30H Parish of Winnaeue; thence westerly by that boundary to Jetty Road; thence north-westerly by that road to Old Cape Schanck Road; thence south-westerly by that road to a point in line with the continuation of Hiscock Road; thence westerly by a line to Boneo Road at Hiscock Road; thence northerly by that road to the centreline of the proposed Mornington Peninsula Freeway reservation; thence south-westerly by the centre of the proposed Freeway reservation to Truemans Road; thence northerly by that road to Booran Parade; thence westerly by that parade to Mathis Avenue; thence westerly by that avenue and Brights Drive to Weeroona Street; thence southerly by that street to the centreline of the proposed Mornington Peninsula Freeway reservation; thence westerly by the centre of the proposed Freeway reservation to Dundas Street; thence southerly by that street to Browns Road; thence generally westerly by that road and line in continuation to the shore of Bass Strait, and thence south-easterly, easterly and north-easterly by that shore to the point of commencement.

BITTERN WARD

Commencing on the shore of Western Port at a point in line with Bayview Road being a point on the eastern boundary of the Shire; thence westerly by a line and Bayview Road to Graydens Road; thence westerly by that road to Boes Road; thence southerly by that road and Hendersons Road to the Frankston-Flinders Road; thence south-westerly by that road to the Bittern-Dromana Road; thence westerly by that road to Balnarring Road; thence south-easterly by

that road to Warrawee Road; thence south-westerly by that road to Stanleys Road; thence westerley by that road to Tonkins Road; thence southerly by that road and a line in continuation to Point Leo Road; thence south-easterly by that road to the Frankston-Flinders Road; thence south-westerly and southerly by that road to Beach Road; thence south-easterly by that road and a line in continuation to the shore of Western Port, and thence north-easterly, south-easterly and generally northerly by the shire boundary to the point of commencement.

TYABB WARD
